St. Rose of Lima Youth Code of Conduct

St. Rose of Lima Youth Ministry promotes an atmosphere where adult leaders and students support one another with genuine respect. As a participant, it is your responsibility to do your part to help make the trip a positive and enjoyable experience for yourself, fellow teens, and adult leaders. All participants are expected to demonstrate high standards of conduct and to accept personal responsibility and consequences for their actions. You are expected to exhibit honesty, courteousness, and consideration toward others. This includes all fellow student participants, adult leaders, as well as anyone else with whom you may come in contact during our activity or trip (i.e. staff of host facility, maintenance or custodial workers, visitors, etc).

Our goal is to make our ministry gatherings safe and enjoyable experience for everyone. We need everyone's cooperation and commitment to the following behavior guidelines to help us meet this goal.

We expect participants to obey the following rules of behavior:

- The participant is to follow the directions and the rules and regulations established by the adult leaders both prior to and during the activity or trip.
- The participant shall not be involved in any way with smoking (including but not limited to: cigarettes, juuls, vapes, e-cigarettes, etc.), alcohol, illegal drugs, vandalism, theft, or any other type of behavior that is judged by the adult leaders to be detrimental to the health, well-being, safety, or character of him/herself or anyone else in the group including the adult leaders.
- The participant is asked to communicate with adult leaders and other participants with encouraging words. Bullying and/or gossiping (in inter-personal verbal communication and on social media) will not be tolerated during the activity or trip.
- The participant will refrain from engaging in "romantic relationships," public displays of affection or entering into opposite-sex only spaces (i.e. bathrooms, dorms, living spaces, etc.).
- During the trip, the participant is not permitted to go anywhere without permission by his or herself. Even when accompanied with a buddy, the participant is only permitted to go somewhere when given permission by an adult leader & the adult leader must know where you are at all times.

If the participant should violate any of these rules, he or she may be sent home at the sole discretion of the adult leaders. In such cases, a parent/guardian will be contacted and the student will be sent home at the parent's expense (will need to be picked up on location by a family member).
