Payment Terms & Agreement

This Tuition & Fees Agreement is a legal contract with *The School of The Holy Family* that **must be signed by ONE** Responsible Party upon enrollment. The Responsible Party is the person that receives the monthly billing statement and the one that is required to make payments. If a person other than the Responsible Party (ex-spouse, grandparent, or other unrelated individual or entity) desires to also assume financial responsibility, he or she must sign a **separate** Tuition & Fees Agreement and remit payments according to the agreed-upon schedule. If only one form is submitted, the full tuition balance will be applied to the account of the Responsible Party. Failure to make payments may result in referral of your account to a collection agency.

There is a 90-day probationary period for all students, during which *The School of The Holy Family* will assess the student's ability to perform adequately in this environment. If the student is deemed unable to perform adequately, *The School of The Holy Family* reserves the right to require a change in a student's program or dismiss the student at any point within the 90-day probationary period. Any prepaid tuition will be pro-rated and refunded.
