THE PRECEPTS OF THE CHURCH PARENT AGREEMENT

The precepts of the Church are *the very necessary minimum of prayer and moral effort needed to grow in love of God and neighbor*. They are detailed in the Catechism of the Catholic Church, paragraphs 2041 – 2043.

The First Precept: *You shall attend Mass on Sundays and holy days of obligation and rest on that day from servile labor.* This is the very necessary minimum of prayer needed to be active in the Christian faith, as the Sunday Eucharist is the foundation and confirmation of all Christian practice (par. 2181).

The Second Precept: *You shall confess your sins at least once a year.*

Again, the very minimum needed for the good of your soul.

The Third Precept: *You shall receive the Sacrament of the Eucharist at least during the Easter season.* This may seem confusing, as the First Precept is to attend Mass every Sunday and holy day of obligation. However, if we go to confession only once a year, we may not always be spiritually prepared to receive the Eucharist even though we are present at Sunday Mass.

The Fourth Precept: *You shall observe the days of fasting and abstinence established by the Church.* To properly prepare for Easter, we fast on Ash Wednesday and Good Friday, and abstain from meat every Friday of the year.

The Fifth Precept: *You shall help to provide for the needs of the Church.*

In order for the Church to accomplish its mission, each person needs to give of their time, talent and treasure, according to their own ability.

By registering my child/children in the Parish Religious Education Program (PREP), I acknowledge my role as primary educator of my child/children (CCC 2223) and recognize how the precepts of the Church are the “very necessary minimum” (CCC 2041) of what I am called to model for my child/children in helping them to be formed as disciples of Christ. I am appreciative of the efforts of the parish to support me in this responsibility. I realize that without a commitment to the precepts of the Church, my child/children will only be confused by what will be taught in PREP, the hard work of those who volunteer to assist me in forming my child/children to become a disciple(s) of Christ would be undermined, and the mission of the parish in providing this educational opportunity would be compromised. And so, with the help of God’s grace, I commit to doing what I can do so that together we might do something beautiful for God.

Specifically, parents/guardians must be given a form to sign that indicates they have been offered the safe environment training, that they decline to have their child participate in such training, and that the diocese has offered to provide safe environment training materials for the parents/guardians to utilize. If the parents/guardians will not sign such a form, a notation of this should be made on the form by the responsible parish/school representatives, and that form should be maintained by the parish and/or diocese.”

This authorization release form shall serve as parental/legal guardian permission for the use of first name and last name initial (name), likeness and/or photographic image of a child/youth where such permission is required. If your child or youth are in a public place that allows for photography, that child or youth are subject to having their photo taken. The person taking the photo cannot use it for "advertising" or intending to show that the person photographed endorses a product.
