

Waiver of Liability Form

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus (“COVID-19”) has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. All Saints Boosters, in collaboration with All Saints Parish (collectively, “All Saints”) has put in place preventative measures to reduce the spread of COVID-19; however, cannot guarantee that you will not become infected with COVID-19. Further, participating in any activity, including but not limited to, sports practices, team events and/or competitions (collectively “Activities”) through All Saints, could increase your risk of contracting COVID-19.

By signing this agreement, I acknowledge, on behalf of myself, my minor child and any other family members (collectively, “I”), the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 while participating in Activities sponsored by All Saints and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 while participating in Activities sponsored by All Saints may result from the actions, omissions, or negligence of myself and others, including, but not limited to, All Saints employees, volunteers, and program participants and their families. Furthermore, I understand there is an elevated risk that I, my minor child, and/or a family member may contract the disease simply by being in the building, on the premises of the school or parish, or at any All Saints function that may be held outside the All Saints premises (including, but not limited to games held at other schools/parishes and practices held offsite).

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind (collectively, “Claims”), that I may experience or incur in connection with participation in Activities sponsored by All Saints. On my behalf (or on behalf of my minor children), I hereby release, covenant not to sue, discharge, and hold harmless All Saints, its employees, agents, volunteers, coaches, and representatives, of and from any and all Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of All Saints its employees, agents, volunteers, coaches and representatives, whether a COVID-19 infection occurs before, during, or after attending any Activity.

PARENTAL ACKNOWLEDGEMENT: I am the minor’s parent or guardian named below and I understand the nature of the Waiver of Liability above and verify and consent to the minor’s

participation in the Activities sponsored by All Saints. On the minor's behalf, I hereby release, covenant not to sue, discharge, and hold harmless All Saints, its employees, agents, volunteers, coaches and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. On behalf of the minor, I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of All Saints, its employees, agents, volunteer, coaches and representatives, whether a COVID-19 infection occurs before, during, or after attending in any Activity.

In addition, I recognize I have specific obligations as the minor's parent/guardian to screen my minor child for COVID-19 symptoms (which include, but are not limited to temperature > 100.4 (forehead), persistent cough, shortness of breath, unexplained body aches, diarrhea, nausea, vomiting, stomach pain, and/or loss of smell/taste) prior to any Activity as well as to disclose to All Saints (to my minor child's coach and the All Saints Boosters President) if my minor child has been exposed (within the previous 14 days) to or is diagnosed with COVID-19.
