Proof of Baptism is always required before the celebration of Confirmation, First Eucharist, Matrimony, or Holy Orders. During each of these sacramental moments the parish of baptism is contacted within six months prior to the celebration of baptism to verify the person's baptism and any other Sacraments already celebrated and to verify the parish to be notified when the celebration is completed so the person's Baptism record can be updated. This verification and notification are required by Church Law in order to keep our sacramental records up to date at the church where we were baptized.
