In consideration of the convenience or necessity for the Authorized Driver to transport my Student to and/or from St. Mary's Catholic School, or an event organized by St. Mary's Catholic School, I hereby, for myself, the child named as Student herein, our heirs, executors, administrators, assigns and personal representatives, (collectively and here after the "**RELEASING PARTIES**") knowingly and voluntarily enter into this *Authorization and Request for Transportation of Student in Privately Owned Vehicle & Waiver and Release of Liability*.

I **AUTHORIZE** and **REQUEST** that my Student be transported in a privately owned vehicle with the above named Authorized Driver, and acknowledge and understand that St. Mary's Catholic School, its employees, agents, representatives, and volunteers (collectively and here after the "**RELEASED PARTIES**" also referred to herein as "St. Mary's School") has not and will not determine or verify the qualifications, safe driving history or insurance coverage of the Authorized Driver, or undertake any inspection of the vehicle to determine its condition, mechanical or otherwise. I further acknowledge and understand that St. Mary's School has made no representation concerning the qualifications, driving history or insurance coverage of Authorized Driver, or the condition of the vehicle.

RELEASING PARTIES hereby **WAIVE** any and all rights, claims or causes of action of any kind whatsoever against St. Mary's School arising out of or related to Authorized Driver's transportation of Student, and do hereby **RELEASE** and forever discharge St. Mary's School from any liability for any property damage, physical or psychological injury, and economic damages including but not limited to medical expenses, disability, disfigurement, death, lost wages, diminished earning capacity, mental anguish and emotional distress arising from the transportation of Student by the Authorized Driver. This **WAIVER** and **RELEASE** includes, but is not limited to, injury caused by negligent acts of third persons, intentional acts of third persons, roadway conditions or hazards, supervision, student misconduct, and disregard of generally recognized safety precautions. **RELEASING PARTIES** further **RELEASE** St. Mary's School from any duty to oversee, or control the manner in which the Authorized Driver operates the motor vehicle.
