- 4. Distance from residence, side property lines and rear property line. Pools and decking must be located within the property side and rear setbacks.
- 5. Location of existing or proposed fence as required by pool code.
- 6. Inground pools must meet the 20% ground coverage limit.
- 7. Copy of signed contract between the property owner and contractor, and copy of copy of license and insurance for electrical, plumbing and gas/propane.

The permit applicants understand and agree that giving reasonable notification to the owner or builder, the P&Z Commission may enter the premises to inspect the site. **Copy of Permit must be displayed at the construction site. Application to be submitted five (5) days prior to review by the Planning & Zoning Commission.**
