NO. 161

AN ORDINANCE BY THE TOWN OF STAGECOACH, TEXAS, AMENDING ARTICLE X, OF ORDINANCE NO. 44, REGULATING TRAFFIC UPON THE PUBLIC STREETS, ALLEYS AND OTHER THOROUGHFARES IN THE TOWN OF STAGECOACH, TEXAS, BY ADDING SECTION 11 TO ARTICLE X, TO PROHIBIT THE PARKING OF TANDEM AXLE TRUCKS AND/OR TRAILERS WITHIN THE TOWN LIMITS; REPEALING ALL ORDINANCES IN CONFLICT, AND PROVIDING EFFECTIVE DATE.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF STAGECOACH, TEXAS:

ARTICLE I.

THAT Article X, of Ordinance No. 44, be amended by adding a Section 11 thereto, which shall read as follows:

"Section 11. NO TRUCK PARKING. No "18-wheelers" or other tandem axle trucks or trailers shall be allowed to park upon any street or roadway or within the right-of-way for any such street or roadway, within the Town limits."

ARTICLE II.

THAT all Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

ARTICLE III.

THAT this Ordinance shall take effect and be in force from and after its passage.

NO. 218

AN ORDINANCE AMENDING ORDINANCE NO. 44  
PASSED BY THE CITY COUNCIL OF THE CITY OF STAGECOACH,  
TEXAS, ON APRIL 20, 1976; CHANGING THE SPEED LIMIT ON A  
PORTION OF STAGECOACH ROAD FROM FORTY MILES PER HOUR TO  
THIRTY-FIVE MILES PER HOUR; PROVIDING FOR THE POSTING AND  
LOCATION OF APPROPRIATE SPEED LIMIT SIGNS; REPEALING ALL  
ORDINANCES IN CONFLICT; PROVIDING FOR SAVINGS CLAUSE; AND  
FOR EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF STAGECOACH,  
TEXAS:

ARTICLE I.

That Section 1.(c) of Article VII of Ordinance No. 44, passed by the City Council of the City of Stagecoach, Texas, on April 20, 1976, be amended by repealing and deleting the entire paragraph designated as Section 1.(a)(1)(a) and by substituting the following paragraph:

"Stagecoach Road from the Eastern corporate limit of the City to Lake Hardin, where the speed limit shall be Thirty-Five (35) miles per hour."

and by adding the following as the final sentence of said Section 1.(c), to-wit:

"Speed limit signs shall be located, in addition to any other locations deemed appropriate by the City Council or the Chief of Police, (i) on the South side of Stagecoach Road just East of its intersection with Alton Wright Road and (ii) on the North side of Stagecoach Road in the general area of the Eastern corporate limit of the City."

II.

That all Ordinances or parts of Ordinances inconsistent or conflicting with the provisions of this Ordinance are hereby repealed.

III.

If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

IV.

This Ordinance shall take effect and be in full force and effect from and after its passage.


