

## **ADOPTION FEE BREAKDOWN (CATHOLIC CHARITIES COUPLES)**

**APPLICATION FEE: \$350**

Covers initial costs of setting up a file, processing finger print background clearances (2 KBI/FBI Repository Checks, \$48 each) (2 Kansas Child Abuse Central Registry Clearances, \$10 each), and processing/mailling references.

\*If you have additional adults (18+ years old) living in your home, subject to extra charges to cover the cost of the additional background check(s).

\*If you have previously lived in a state other than Kansas, you will be required to pay for the cost of Child Abuse and Neglect Clearances for each additional state in which you have lived within the last five years - fees vary by state.

**ADOPTION PREPARATION AND EDUCATION FEE: \$105 or \$135 (paid online)**

Processing/maintenance of home study paperwork, case management, sharing profiles with Catholic Charities agencies statewide, phone calls, emails, unconsummated placement activities, and marketing services including enrollment through [www.ParentFinder.com](http://www.ParentFinder.com)

**CATHOLIC CHARITIES HOME STUDY: \$1,000 plus mileage**

The home study may be used for one year, either for an agency or independent adoption.

**HOME STUDIES (THAT ARE LESS THAN ONE YEAR OLD) DONE INDEPENDENTLY OR BY ANOTHER AGENCY: \$250 plus mileage & additional costs (education, clearances)**

These will be evaluated to verify the accuracy of the information. This will include a home visit for verification of initial home study information

**ADOPTION PLACEMENT FEE: 8% of gross income**

(based on the previous year 1040 tax form)

Minimum placement fee = \$6,000 and Maximum placement fee = \$10, 950
