- I. Faith Sharing led by Mike Ruebensaal (Mark 1:29-39)
- II. Update on Property Sale: In the hands of the lawyers to “fine tune” the sale. Payment of \$148,000 will be in 2 installments, the first one in April 2021 and the second one in April 2022. Bishop will have final sign with Our Lady Queen of Peace receiving all monies from the sale.
- III. Update on Building Phase: Building Committee will have their first meeting on February 18th. Mike Serdinak (architect) is performing a “soft” assessment of the current buildings and our needs with minimal cost to the parish. Survey was given to all members requesting them to complete and turn into the office before the scheduled Building Committee meeting on February 18th. This will help the firm with the “soft” assessment.
- IV. Update on CLI: Disciple Maker Index Survey: Survey is open to all parishioners of Our Lady Queen of Peace beginning February 20, 2021 through March 22, 2021. It will be available via a link online or by paper, for those unable to access the online survey. Small discussion on anonymity and collection of paper ballots. - VI. Update on Flocknote: Greg Dore gave informative slide presentation of Flocknote’s many uses and features. Communication team was formed with Greg Dore, Esther Stanard, Darlene Stutz and Jim Andrews. Parish Council agreed to move forward with payment of \$58 a month per 500 users. If Our Lady Queen of Peace is not satisfied – able to terminate at any time.
- VII. Lenten Preparation Details: Will be utilizing Joyful Disciples “Commitment to Pray” card that was presented last year, with certain adaptations due to COVID this year.
 - a. Eucharistic Adoration will be once a week for one hour time.
 - b. Ash Wednesday Mass times are 9:30AM and 7:00PM on February 17th. Ashes will be administered via Q-tip swabs.
 - c. Holy Week Masses will be observed.
 - d. Confessions will be heard Saturday’s at 1:30PM.
 - e. Easter Weekend Masses will most likely be attended via reservations only.
