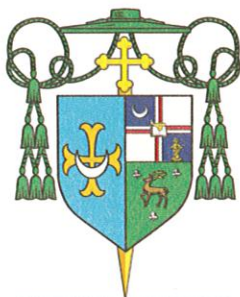

"Teen Lures" will be taught in all of our parish youth ministry programs and Catholic High Schools. I am asking that you have the "Teen Lures" program implemented beginning January 2016.

The "RCL Family Life" series will continue to be the official safety program of the Diocese of Trenton for all K-8 students and will be taught in all of our parish Religious Education programs and Catholic Elementary Schools.

I will continue to endorse the VIRTUS, Protecting God's Children Program for Adults, as the Official Safe Environment program for all of our employees and volunteers, who have significant contact with children, youth and vulnerable adults.

Thank you for all you do to pass on the truth of our faith, protect our children, and teach them the beauty of Catholic moral teaching.
