

HOW TO DETERMINE A PRIOR BOND (*LIGAMEN*) CASE

Can. 1085.1°: A person bound by the bond of a prior marriage, even if it was not consummated, invalidly attempts marriage.

Can. 1085.2°: Even if the prior marriage is invalid or dissolved for any reason, it is not on that account permitted to contract another before the nullity or dissolution of the prior marriages is established legitimately and certainly.

| A copy of the marriage certificate of the marriage to be declared invalid, |
| that is, the marriage certificate of the petitioner and the respondent. |
| A copy of divorce decree of the marriage to be declared invalid, that is, the |
| divorce decree of the petitioner and the respondent. |
