2018-19 Coaching Code of Conduct Agreement

I agree that I have read the St. Mark Catholic School Athletics Handbook and the Parent-Student Handbook, and will abide by the rules and guidelines contained therein.

I will attend and complete all coaching requirements: Safe Environment, CPR, and PLC courses.

I will communicate in my pre-season parent meeting that all parents must read Athletics Handbook and abide by the policies therein.

I will report any infraction of the rules to the school Athletic Director, Marlene Ehring.

I will not contact the DPL Athletic Director at any time for any reason.

I will not contact the school Principal or Assistant Principal on sports-related matters without permission from the Athletic Director.

I will stay informed about, and comply with, all school and DPL rules and directives.

I will not use alcohol, drugs, or tobacco related products in the presence of players, coaches, officials, and/or volunteers while representing St. Mark.

I will not use foul or abusive language at any time while representing St. Mark.

I will teach Christian values, respect, discipline, honesty, and hard work.

I will instruct the players in their sportsmanship responsibilities.

I will take all precautions to protect student athletes, equipment, materials, and facilities.

I will respect the officials' judgment and interpretation of the rules. I will address concerns to officials in a calm manner during dead ball situations.

I will publicly shake hands with the officials and opposing coach before and after every competition.

I will instruct my team to pray and to shake hands with the opposing team and the officials prior to every competition, and to shake hands with the opposing team and the officials after every competition.

I will be a proper host to opponents, treating them like guests. I will remind spectators that the opposing team needs their respect and courtesy.

I will discipline those students/athletes who display unsportsmanlike behavior, and if necessary, forfeit the privilege of representing their school.

I will not use corporal punishment for discipline.

I agree that both coaches will be present prior to the scheduled practice start time in order to meet the athletes upon their arrival. Students may not enter a practice facility without two Safe Environment trained adults present.

I will remain with the athletes until each has been released to their parent/guardian, whether at a game or practice.

I will be fair and maintain an unprejudiced relationship with all team members.

I will make every effort to ensure that players receive a fair amount of playing time.

I understand I must be supportive in everything I do and say; I will not assault others verbally or in writing.

I will not conduct off-site practices unless given permission by the Athletic Director.

I will notify the Athletic Director of any team concerns presented to me.

I will not allow any unsupervised children to attend practices. Athletes and coaches must be able to remain focused and disciplined without distractions.

I will always be a good example for others to follow.

As a coach, I understand that any negative conduct exhibited by me within the confines of a DPL competition is subject to disciplinary measures from the DPL.

As a coach, I understand that any negative conduct exhibited by me outside the confines of a DPL competition is subject to disciplinary measures from the school.
