### PK- 3 & 4 year old

_____ Half day AM Program - 3 Days (Tues.,Wed.,Thurs.)	\$2,300 per child
_____ Half day AM Program - 5 Days	\$3,300 per child

(5 day PK-3 half -day program will require a minimum enrollment of 5 students)

### PK - 4 year old

_____ Full Day Program - 3 Days (Tues.,Wed.,Thur.s)	\$3,600 per child
_____ Full Day Program - 5 Days	\$4,200 per child

### K – 8<sup>th</sup> Grade

_____ Kindergarten through 8 <sup>th</sup> grade	\$3,900 1 <sup>st</sup> child
_____ Kindergarten through 8 <sup>th</sup> grade	\$3,075 2 <sup>nd</sup> child
_____ Kindergarten through 8 <sup>th</sup> grade	\$1,800 3 <sup>rd</sup> child

**SMART Tuition Fee (non-refundable) - \$35 per family**

**Technology Fee - \$50 per student or \$100 per family**

**Registration Fee (non-refundable) - \$100 per child      \$300 maximum per family**

**St. Charles Borromeo (Drexel Hill)** provides a \$1,000 per student subsidy for registered members of St. Charles Borromeo Parish who actively support the parish. This subsidy applies to students enrolled in SAS - grades 1<sup>st</sup> through 8<sup>th</sup> grade only. Any changes in the amount of subsidy will change the tuition charges. Eligibility for these subsidies is determined by the parish providing these subsidies.

**St. Philomena (Lansdowne)** provides a \$800 per student subsidy for registered members of St. Philomena Parish who actively support the parish. This subsidy applies to students enrolled in SAS - Kindergarten through 8<sup>th</sup> grade only. Any changes in the amount of subsidy will change the tuition charges. Eligibility for these subsidies is determined by the parish providing these subsidies.

All tuition installment payment plans: - monthly / 10 equal installments [June - March]; quarterly [June, September, December & March]; and semi-annual [July & December] are handled through SMART Tuition ([www.smarttuition.com](http://www.smarttuition.com)). Annual pay families are billed through the parish in late July and are not charged the \$35 SMART Application Fee.
