Terms of Rental

1. St. Matthew Church and its agents, servants and employees, and the Catholic Archbishop of San Antonio shall not be held liable for the condition of premises, or for any accident or injury to a participant or to any other person or damage to property as a result of the conditions of the premises or as a result of any act on the part of the Renter, the participants or any spectator. The Renter, spectators and participants of the Event accept the premises in the condition existing on the date of the Event.
2. The Renter accepts complete responsibility for any damage to the facility(ies) rented and/or to the surrounding areas as a result of the Event.
3. Food and/or beverages will not be sold or served at the park except as may be arranged through the Parish Athletic Director. The Church reserves the right to operated all refreshment and/or snack stands.
4. The Renter will be responsible for providing at their expense coaches, referee officials, administrator, and/or competent technical/electrical personnel as required to operate facility(ies) rented in a safe manner.
5. The Renter will provide parking lot attendants (if this is deemed necessary) at its own expense. The school will not be held responsible for damage to automobiles or theft of articles from automobiles. The Renter shall not levy a charge for parking without the consent of the Church.
6. St. Matthew Church asks your cooperation in helping to maintain the facility(ies) rented and/or surrounding areas cleaned and free from damage. Only with your help can we hope to keep our park clean and attractive, and assure you and your group the future use of St. Matthew facilities.
7. Renter shall indemnify and save harmless the Archdiocese of San Antonio, St. Matthew Church and employees, agents and representatives form and against claim, demand, cause of action for personal injury or property damage of every kind and character and all losses, liabilities, costs, expenses (including attorney's fees), with limit or limitation, and with regard to the cause or causes thereof, ore the negligence of party or parties, including the negligence of Renter, whether such negligence be sole, joint or concurrent, for injury, illness or death of any person or damage to any property arising out of or in connection with this agreement or Renter's use of St. Matthew Church property.

It is the express intention of the parties hereto that under this Indemnity and Hold Harmless Agreement, Renter shall indemnify and protect St. Matthew Church from the consequences of St. Matthew Church's own negligence of gross negligence, whether real of alleged. Renter acknowledges that it has read the foregoing Indemnity and Hold Harmless Agreement, knows its content, meaning and effect and has signed it voluntarily, willingly and with out reliance upon any representation of St. Matthew Church.
