## IN MEMORIAM: LARRY MAHER

Larry Maher was a friend of mine; as he was to many of you here today. I didn't realize what a daunting task it would be to say a few words about him here today. For when I began to think about it, it dawned upon me that no tribute would do him justice. For you see, I met him late in his long life, after he'd retired from government service and after his beloved wife, Mary, had passed away. He was in his 80's and I was in my 50's; so I knew him for about 1/10 of his life. But not too long after I got to know Larry Maher, I felt like I had known him for a lifetime.

I discovered Larry Maher, as many of you did, as "Larry the Piano Man." When I first saw him playing up at the Alpine, sitting behind the piano in his black Tuxedo, I knew I was in the presence of a star; "Larry the Legend," as they called him at the Dogwood Cafe. His eyes would light up and an enchanting smile would come over his face and he'd start playing those lovely melodies on the piano and I may as well have been listening to the likes of Frank Sinatra or Dean Martin. Man, he loved to play that piano.

But as much as I loved to sit and listen to Larry play the piano, it was a special treat to sit down and have a conversation with Larry Maher. I found him to be a perfectly preserved example of the Virtue and Civility of the men of the Greatest Generation; many of our father's generation and he reminded me of many of the qualities I remembered in my own father.

He could have been among those WWII Veterans that have come from all over the nation to be recognized at the Knights of Columbus in Arlington – Larry's Club. Sure enough, I was recently telling Larry how I had taken a trip to visit Normandy and was overwhelmed by the hallowed majesty of the place. And, sure enough, Larry told me: "Tim, I was at Normandy." And before I could catch my breath to express my astonishment, he assured me that he hadn't come until a week after the

invasion to clean up the mess, as he put it.

Still, as an exemplar of his generation, he was simply brimming with Gentility & Gentleness;

Grace & Graciousness; Charity & Charm; Sensitivity & Sense; Humor & Humility . . . . Stop me when I've gone too far! In a world that surrounded you with clatter and confusion, Larry Maher always seemed, for a brief moment in time, to draw you into his Zone of Serenity. He brought with him a calm in which all made sense in the world once again.

What I am trying to get at here is that Larry Maher and I always listened to each other's stories and laughed at each other's jokes and I challenge anyone to give a more simple definition of a true friend than that.

And he loved life to it's fullest; a week before he passed, he ventured out with Laura to the Knights of Columbus for a festive beer or two to celebrate the going away party of a friend of his Jack Waters. And even up until the last minutes of his life, he was enjoying it, watching his adopted home-town team, the Washington Nationals, play baseball. The Nats lost the game on a grand slam home run in the bottom of the ninth inning and Larry Maher was felled by a stroke. The Post headline the next morning read: "Heartbreak Home Run Stuns Nationals," and, it could have added, it took Larry Maher with it.

Yes, Larry Maher was a friend of mine and we celebrate the long life of Larry Maher but note too his passing. Because, to paraphrase an old Irish song: "We'll never see the likes of him again."
