Palm Sunday of the Lord's Passion

Today we commemorate the passion of our Lord. In the garden, Jesus asked his Father to let this cup pass from him if it were possible, but reaffirmed his desire to do his Father's will. Through the act of sacrifice, the gates of heaven were opened to us. The first reading from Isaiah bears witness to the suffering and eventual death of an Israelite prophet, as well as foreshadows the suffering and death of Christ. This suffering servant song, composed nearly six hundred years before Jesus' passion and death, confirms the divine orchestra of our salvation.

In the second reading from the Letter to the Philippians, Paul inserted this Christological hymn as a means of defining the cross in relation to Christ and emphasizing his humility. It serves as an important reminder as to why we confess "Jesus Christ is Lord."

This is the solemn narrative of the passion and death of our Lord Jesus Christ. Matthew recounts the treachery and betrayal of Judas and then describes the events of the Last Supper, culminating in the institution of the Eucharist. Jesus endures the Agony in the Garden; he is then brought before Caiaphas and Pilate and condemned to death. After His resurrection, the centurions shouted, "Clearly this was the Son of God!"

Coronavirus Update

The Archdiocese will continue to monitor advisories from Catholic and other organizations regarding precautions on the Coronavirus and share any appropriate information with all of the faithful and specifically with the OLG&STM parish.

All public Masses are canceled, until further notice, including both Sunday and weekday Masses. Both the church of Our Lady of Good Counsel and the church of St. Thomas More are open daily from 9:00am to 3:00pm for private prayer. Upon reasonable request, confessions may be heard, preferably by "appointment" in the parish office or some other appropriate place, such as the church when it is open for private prayer.

Holy Week Schedule

Unfortunately, the virus will prevent our parish from celebrating the Holy Week Feast Days in both our parish churches this year. We encourage you to access the on-line remote-worship resources that are available to you.

The Distribution of Palms will take place on a post-virus feast such as the Solemnity of the Body and Blood of Christ on June 12th.

Act of Spiritual Communion: It has long been a Catholic understanding that when circumstances prevent one from receiving Holy Communion, it is possible to make an Act of Spiritual Communion, which is a source of grace. Spiritual Communion is an ardent desire to receive Jesus in the Most Holy Sacrament and lovingly embrace him at a time or in circumstances when one cannot receive Him in sacramental Communion. The most common reason for making an Act of Spiritual Communion is when a person cannot attend Mass. Acts of Spiritual Communion increase our desire to receive sacramental Communion and help us avoid the sins that would make us unable to receive Holy Communion worthily.

Prayer for Spiritual Communion: My Jesus, I believe that you are present in the Most Holy Sacrament. I love you above all things and I desire to receive you in my soul. Since I cannot at this moment receive you sacramentally, Come at least spiritually into my heart. I embrace you as if you were already there and unite myself wholly to you. Never permit me to be separated from you. Amen.

Prayers of Praise: In addition to praying for communion with the Lord, it is also important to take time to offer God our praise. This can be done by celebrating the Liturgy of the Hours or through a Celebration of the Word service, which can be celebrated at home.
