The Solemnity of the Most Holy Trinity

Sunday of the Most Holy Trinity celebrates the mystery of our God, revealed to us as three persons, one in being, and in full communion with one another, and challenges us to come to know God best through *relationships*. In today's reading it is noteworthy to hear how God is characterized: "a merciful and gracious God, slow to anger and rich in kindness and fidelity." Moses' reverence and humility before God, along with his apology for the sins of the Israelites, should be heard in the context of the blasphemy of the golden calf and the destruction of the first set of stone tablets.

The second reading is taken from the concluding remarks in Paul's Second Letter to the Corinthians. It is a beautiful and calm ending to an otherwise very difficult letter. Throughout the letter, Paul defends himself against his opponents in Corinth who challenge his authority and status as an apostle. Despite the high emotions and troubling tone of the letter, Paul ends with words of encouragement for the congregation to live a holy and peaceful life with one another. The final words provide one of the New Testament's earliest Trinitarian formulas: "The grace of the Lord Jesus Christ and the love of God and the fellowship of the Holy Spirit be with you all."

The Gospel reading from John is one of the most well-known texts of the New Testament. It speaks not only to the intimacy and love between the Father and the Son, but also to the passion our God has for the world.

Coronavirus Update: The Archdiocese will continue to monitor advisories from Catholic and other organizations and has developed the *Faith Forward* guidelines <https://archny.org/faithforward/>

to help us as we slowly move toward reopening. In the meantime, all public Masses are canceled, until further notice, including both Sunday and weekday Masses. Both the church of Our Lady of Good Counsel and the church of St. Thomas More are open daily from 9:00am to 3:00pm for private prayer. Upon reasonable request, confessions may be heard, preferably by "appointment" in either church.

When we finally begin to reopen the church, you will notice several differences. The first and most obvious will be the seating limitations, the requirement to use a hand sanitizer when entering, the absence of holy water or water in the baptismal font, the need to maintain safe distancing and the need to wear a mask while in the church. Next will be the absence of any books in the pews. All of the music books will be removed and placed in storage (along with the STM pew cushions) and missalettes replaced with a single use (disposable) program with the Sunday Readings and Music. You will also see members of our parish maintenance staff engaged in a much more aggressive cleaning program before each Mass. Finally, and most importantly, there will be no physical contact during the Sign of Peace, the Precious Blood will not be distributed and it is strongly recommended that each Communion recipient should receive the Host reverently in open hands for the protection of all. Due to governmental protocols we will be allowed to seat only one quarter of the usual capacity. Seating at STM will be limited to 80 people. This should not be a problem during the summer, when attendance is historically much lower than usual. It may be an issue at the noon Mass at STM, so it is suggested that one attend the 10:00 Mass to insure admittance. If the Sunday 5:30 Mass at STM has reached capacity, those coming later will have to proceed to OLG, which can accommodate more than 200. Seating at OLG should not be a problem. It is our hope that these changes will do nothing to interfere with your participation in the Mass and will help us to move carefully and safely toward our goal of full reopening. We thank you in advance for your understanding and cooperation.

Outline of the General Plan to Reopen

It is expected that different regions of the Archdiocese will begin the process of reopening at different times. When the Archdiocese Office of the Vicar General believes that the required conditions have been achieved to permit a change in status, the Archdiocese will announce the commencement of the new step and permit a parish to move to the next phase based the specific conditions found in each unique parish.

1. Currently, we are in the first phase, which permits us to open our church for private prayer and scheduled confessions.
2. The next phase, which will commence at a later date, will be the resumption of small religious services (baptisms and marriages) all under the ten-person limit.
3. The third phase will be distribution of Holy Communion without Mass during the week.
4. The fourth phase will be limited weekday Masses and funeral Masses.
5. The last phase will be Sunday Mass with supervised attendance.
