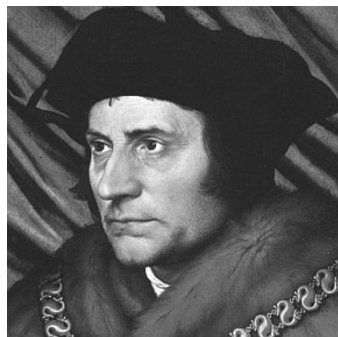

## Solemnity of the Most Holy Body and Blood of Christ (Corpus Christi)

The Catholic belief in the real presence of Christ in the Eucharist is one of the central mysteries of our faith, and the readings for today offer some insights into the mystery of how the body and blood of Christ offer salvation to the world. The first reading is taken from the Book of Deuteronomy, which is basically a series of speeches that Moses delivers to the next generation of Israelites. Moses instructs the Israelites with two important lessons learned in the desert. First, the manna from heaven—came from the Lord, and illustrated their dependency on the word of God. Second, it was God who made the impossible possible.

The second reading is taken from Paul's First Letter to the Corinthians. For Paul, the body and blood of Christ shared in the Eucharistic meal was the believing community's "participation in the body of Christ".

In the Gospel reading for today. Jesus directs his comments "to the Jewish crowds." This is an important qualifier, since the Jews would know well the idea of "bread that came down from heaven." The Jewish crowd quarreled among themselves at Jesus' words of eating the bread of eternal life that he offers, ironically, much like the original Israelites in the desert quarreled with Moses.

to help us as we slowly move toward reopening. In the meantime, all public Masses are canceled, until further notice, including both Sunday and weekday Masses. Both the church of Our Lady of Good Counsel and the church of St. Thomas More are open daily from 9:00am to 3:00pm for private prayer. Upon reasonable request, confessions may be heard, preferably by "appointment" in either church.

### Outline of the General Plan to Reopen

It is expected that different regions of the Archdiocese will begin the process of reopening at different times. When the Archdiocese Office of the Vicar General believes that the required conditions have been achieved to permit a change in status, the Archdiocese will announce the commencement of the new step and permit a parish to move to the next phase based the specific conditions found in each unique parish.

1. Currently, we are in the first phase, which permits us to open our church for private prayer and scheduled confessions.
2. The next phase, which will commence at a later date, will be the resumption of small religious services (baptisms and marriages) all under the ten-person limit.
3. The third phase will be distribution of Holy Communion without Mass during the week.
4. The fourth phase will be limited weekday Masses and funeral Masses.
5. The last phase will be Sunday Mass with supervised attendance.
