Twelfth Sunday in Ordinary Time

In today's reading, the issue of fear, and specifically the fear of those called by God to preach his word, is put before us as both our consolation and our challenge. Jeremiah's complaint that those to whom he preached and ministered had turned against him was a valid one. Yet for all his grouching, the prophet believed in God's abiding presence ("But the Lord is with me"). Therefore he willingly embraced his ministry, offering himself, albeit grudgingly at times, as a guide to fearful people and mobilizing them toward liberation from their sin.

In the second reading, Paul celebrates the fact of salvation as a gift which forever liberates humankind from the only things deserving of fear: sin, death and separation from God.

In today's gospel, Jesus is shown counseling his apostles against exercising their ministry in fear by assuring them of the Father's constant and careful attention to their well-being.

Coronavirus Update: The Archdiocese will continue to monitor advisories from Catholic and other organizations and has developed the *Faith Forward* guidelines <https://archny.org/faithforward/>

to help us as we slowly move toward reopening. In the meantime, all public Masses are canceled, until further notice, including both Sunday and weekday Masses. Both the church of Our Lady of Good Counsel and the church of St. Thomas More are open daily from 9:00am to 3:00pm for private prayer. Upon reasonable request, confessions may be heard, preferably by "appointment" in either church.

Outline of the General Plan to Reopen

It is expected that different regions of the Archdiocese will begin the process of reopening at different times. When the Archdiocese Office of the Vicar General believes that the required conditions have been achieved to permit a change in status, the Archdiocese will announce the commencement of the new step and permit a parish to move to the next phase based the specific conditions found in each unique parish.

1. The second phase, will begin on Monday, June 22, 2020. This phase will permits us to open our church for private prayer, confessions, small religious services (baptisms and marriages) all under the ten-person limit and limited weekday and funeral Masses.
2. The third phase, which will begin at a later date, will permit Sunday Masses with supervised attendance.
