Admissions Policy

St. Charles Borromeo School admits students of any race, color, national and ethnic origin to all the rights, privileges, programs, and activities accorded or made available to students at the school. Applicants and students are not discriminated against on the basis of race, color, or nationality and ethnic origin in administration of admission and educational policies and in athletic and other school-administered programs.

New student registration is the week of February 3 – February 7, 2020. Registration paperwork and payments are accepted at any time, but will not be processed until after February 7, 2020.

Admission is based on available space, school records (academic and behavioral), parental/student interviews, and standardized test results. The school administers a screening for all enrolling for the first time.

1. All **students presently enrolled** may participate in “Returning Student” registration provided that they are in good standing and all financial obligations to the school are fulfilled.

2. All **faculty members employed** by St. Charles Borromeo have priority in registering their children.

3. All **families presently enrolled** have priority in registering siblings of their children.

4. **Parishioners** will be given priority according to the three - fold definition of a **parishioner** as promulgated by the Archdiocese of New Orleans.

- 1) A parishioner must be “REGISTERED” in through the parish office he/she desires to practice our faith.
- 2) A parishioner must be “ACTIVE” in their registered parish through several venues
 - a) Attend Mass regularly (weekly), go to confession regularly
 - b) Become active in the many ministries our parish has to offer
- 3) A parishioner should be “CONTRIBUTING” in thanksgiving for the many gifts that our Lord has blessed each of us with.
NOTE: Minimum contribution 1 Child.....\$500.00/year;
2 Children.....\$700.00/year; 3 Children.....\$800.00/year

5. **Catholics from parishes with no school or a parish school without room who provide a parish affiliation voucher (K-7 only)** are accepted first. The registration of **Non-Parishioners** is accepted as space permits, followed by **Non-Catholics**.

Admission Requirements

Any new student accepted into St. Charles Borromeo for the pre-kindergarten 3, pre-kindergarten 4, and kindergarten program must be of age by **September 30th**. All new applicants will be administered a screening prior to acceptance. All obligations to the previous school attended must be met in order to be considered for admission to St. Charles Borromeo. Students applying for Pre-Kindergarten 3 and Pre-Kindergarten 4 programs must be fully potty-trained (ability to use the bathroom without any assistance). We consider a child to be fully potty trained if the child can independently verbalize their need to use the restroom as well as fully take care of their own needs in the restroom.

Copies of the following certificates must be presented at the time of registration. Please do not present the originals.

1. The official registered State Birth Certificate (not the hospital certificate)
2. Certificate of Baptism
3. Immunization Records - The Louisiana State Board of Health requires schools to refuse admission to students who do not furnish the following immunizations, signed and dated by a physician or Health Unit:
HIB (Haemophilus Influenza B)
Varicella (Chicken Pox) (2)
DPT/DT/Td (4)
MMR (Measles, Mumps, Rubella) (2)
Polio (OPV/IPV) (3)
Hepatitis B (HBV) (3)

Note: The 4th DPT, 4th Polio, and the 2nd MMR MUST have been administered AFTER your child’s 4th birthday and prior to entry into Kindergarten. Students entering sixth grade must provide proof of a recent Tetanus (TdAP) and meningococcal vaccines.

4. Students applying for first through seventh grades must present their most current report card with any standardized test results along with the certificates mentioned in items 1, 2, and 3 above.
