In 1973, the U.S. Supreme Court ruled that a person outside the womb had the “right” to end the life of a person inside the womb. The law of mankind granted people these “rights” but the Law of God still says, “*Thou shall not kill*” (Exodus 20:13).

Prior to 1973, the laws in America protected the rights of human beings outside and inside the womb. How can our *Declaration of Independence* say that every human being has the right to “*life, liberty and the pursuit of happiness*” and then not grant these same rights to the human being living inside the womb?
