

# TUITION CONTRACT

## 2019 – 2020

The following items are due by **Friday, March 1, 2019:**

- ❖ This CONTRACT completed, signed and dated; **ONE** per family.
- ❖ *A non-refundable REGISTRATION FEE for each student of \$200.*
  - Technology Fee is included.
  - Students will be scheduled for classes once we receive the Tuition Contract with Registration Fee.

### FINANCIAL OBLIGATIONS

#### 1. FUNDRAISING

- EACH STUDENT is required to sell eight (8) raffle calendars @ \$25 per calendar totaling \$200. This is the only **MANDATORY**, all-school student fundraiser;

#### 2. MISCELLANEOUS

- In order for a student to receive his/her class schedule this summer and any school-sponsored tuition assistance for the 2019-2020 school year, payments and all financial obligations from the previous 2018-2019 school year must be complete and the tuition payment current through July 15, 2019.
- Students who withdraw during the first semester are obligated for tuition payment for half the yearly tuition cost *through December 20, 2019*. Students who withdraw during the second semester are obligated to pay full year tuition cost *through April 15, 2020*.
- ALL STUDENTS: Report cards, transcripts, and Progress Book access will be withheld for non-payment of financial obligations to the school.

#### 3. SENIORS ONLY

- GRADUATION FEE of \$100 will be billed separately in the fall.
- TUITION ACCOUNTS must be paid in FULL before the student will be permitted to participate in Commencement. Post-dated checks will not be accepted for payment of tuition.
