The following items must be returned **February 19, 2021**.

- This completed contract on the reverse side, **signed and dated by both parents/guardians**. Only one contract per family. Unsigned contracts will be returned.
- A **non-refundable** Registration Fee for each student of \$200.

Students will be scheduled for classes once we receive the tuition contract and registration fee.

Financial Obligations

1. Seniors Only

- A Graduation Fee of \$100 will be billed separately in the fall.
- Tuition accounts must be paid in full before the student will be permitted to participate in Commencement. Post-dated checks will **not** be accepted.
- Year-end transcripts will not be sent to colleges if tuition is not paid.

2. Fundraising

- Each student is required to sell \$200 in raffle tickets for the Student Scholarship. This is the **only** mandatory all-school student fundraiser.

3. Miscellaneous

- In order for a student to receive his/her class schedule and any school-sponsored tuition assistance, all financial obligations from the previous school year must be paid in full. In addition, the first payment must be made.
- Students who withdraw during the first semester are obligated for half the yearly tuition. Students who withdraw during the second semester are obligated to pay the full year tuition.
- Report cards, transcripts and Progress Book access will be withheld for non-payment of financial obligations to the school.
- Students will not be able to return to school for the second semester if payment has not been made for the first semester. Any special arrangements may only be made with the Director of Finance, President, or Principal.
- Athletic fees are billed separately by the sport season.
