From the Archdiocese of New York...

Now that our parishes in Dutchess, Orange, Putnam, Rockland, Sullivan, Ulster, and Westchester counties have entered Phase II of the New York State's reopening plan, and with New York City following on Monday, offices and rectories can resume operations at limited capacity. The health and safety of our staff, volunteers, and visitors is of the utmost importance as we move into this period of transition.

Throughout the reopening process we will adhere to the guidelines set out by the state. NYS Phase II limits the total number of occupants for offices and other business spaces at any given time to no more than 50% of the maximum occupancy for a particular area as set by the certificate of occupancy, with a distance of six feet to be maintained amongst staff at all times. If this distance needs to be encroached to complete a task, face masks must be worn. As an additional precaution, we are recommending that face masks be worn at all times in the office or rectory, if possible.

There are a number of measures that can be implemented to enhance the experience for those returning to the workplace, such as staggered arrival and departure times, alternate schedules for staff/teams to be present in the office, rearranged workspaces to allow required distancing, and having sufficient cleaning and disinfectant supplies. Remember, wearing masks and regular hand washing are still required measures to limit the potential spread of the virus. In addition, you can contact Mr. Frank Napolitano, director of insurance and risk management at 203-253-7736 for recommended cleaning companies in your area that have been used by many of our parishes and schools in recent months to conduct more frequent cleanings. Take into account the concerns of staff who may be more susceptible to the coronavirus due to age or underlying health conditions. Consider making accommodations to address concerns of those employees who would be deemed a high risk for potential COVID-19 infection (i.e. over 65 years of age, or with compromised health conditions).
