Why the "St. Gabriel" Society?

Our mission, as parish and church, is to do the same. Through our generosity, charity, service and worship, we continue the work of proclaiming Christ to the world around us. Each of us shares in this mission.

St. Gabriel Legacy Society Membership

There are a number of ways to include Holy Angels Parish in your estate plan and become a member of the St. Gabriel Legacy Society, including the following:

- Through a bequest in your Will, Codicil or Trust, either of a specific dollar amount, a percentage of assets, or as a remainder or contingent beneficiary
- By designating the parish as a partial or full beneficiary of an IRA or retirement account
- By naming the parish as the beneficiary, and perhaps even the owner, of a new or existing life insurance policy
- By designating the parish as a beneficiary of a Payable on Death or Transfer on Death bank or brokerage account
- By establishing a Charitable Gift Annuity, Permanent Named Fund or a Donor-Advised Fund with the Catholic Community Foundation and naming the parish as beneficiary
- By creating a Charitable Remainder Annuity or Unitrust, or a Charitable Remainder Lead Trust and naming the parish as the charitable beneficiary
