**Description**

BEGINNING at the point where Leroy Parkway, which is also known as FM 308 intersects the McLennan-Hill County Line;

THEN southeasterly along the McLennan-Hill County Line, past the point it intersects the Hill-Limestone County Line, and continuing in the same direction along the McLennan-Limestone County Line until it intersects the McLennan-Falls County Line;

THEN southwesterly along the McLennan-Falls County Line until it intersects Highway 6, which is also known as Memorial Street;

THEN northwesterly along Highway 6 until it intersects Harrison Road in the town of Harrison;

THEN northerly along Harrison Road until it intersects Somerfeld Road;

THEN westerly along Somerfeld Road until it intersects Trading Post Road;

THEN northerly along Trading Post Road until it intersects Elk Road, which is also known as FM 2491;

THEN northeasterly along Elk Road until it intersects Double EE Ranch Road;

THEN northerly along Double EE Ranch Road until it intersects Old Mexia Road;

THEN northeasterly along Old Mexia Road until it intersects Beaver Lake Road;

THEN northerly along Beaver Lake Road until it intersects Highway 84;

THEN westerly along Highway 84 until it intersects Old Axtell Road;

THEN northeasterly along Old Axtell Road until it intersects Pleasant Hill Road;

THEN northerly along Pleasant Hill Road until it intersects Bays Road;

THEN continuing northerly and then southwesterly along Bays Road until it intersects Monthie Road;

THEN northwesterly along Monthie Road until it intersects Mazanec Road;

THEN southwesterly along Mazanec Road until it intersects Oak Knoll Lane;

THEN northwesterly along Oak Knoll Lane until it intersects Lincoln City Road;

THEN northeasterly along Lincoln City Road until it intersects Kelinske Road;

THEN northwesterly along Kelinski Road until it intersects Leroy Parkway, also known as FM 308;

THEN northeasterly along Leroy Parkway until it intersects Baese Road;

THEN northwesterly along Baese Road until it intersect Grudziecki Road;

THEN northeasterly along Grudziecki Road until it intersects Baese Road;

THEN northerly along Baese Road, past the point where it crosses E. Tours Road (FM 3149) at which point Baese Road becomes known as Heitmiller Road, and continuing in the same direction along Heitmiller Road until it intersects Easy Road;

THEN northeasterly along Easy Road, past the point where it crosses Heritage Parkway (FM 2311) at which point Easy Road becomes known as Snider Road, and continuing in the same direction along Snider Road until it intersects Czech Hall Road;

THEN northerly along Czech Hall Road until it intersects Cervanka Road;

THEN northeasterly along Cervanka Road until it intersects County Line Road;

THEN southerly along County Line Road until it intersects 3 E Road;

THEN easterly along 3 E Road until it intersects the McLennan-Hill County Line;

THEN southeasterly along the McLennan-Hill County Line to the POINT OF BEGINNING.
