## TUITION SCHEDULE SY 2021-2022

### Kindergarten – 8<sup>th</sup> Grade

1 Child	\$ 3,800
2 Children	\$ 6,275
3 Children	\$ 7,275
4 Children	\$ 7,600
5 or more Children	\$ 7,600

### Pre-School Rates / 5 days a week / All Day

Preschool families who have at least one student enrolled in K-8 for the 2021-2022 school year = \$4,000 per child

Preschool families who only have students enrolled in Preschool for the 2021-2022 school year = \$4,400 per child

### Pre-School Flex Program

3 days a week / All Day	\$ 2550
5 days a week / Half Day	\$ 2400
3 days a week / Half Day	\$ 1600

Each family is expected to sell ten Mega-Raffle tickets at \$50.00 for the Heritage Days/Summerfest. If a family does not sell ten (10) tickets the difference will be added to their current tuition.

Book/Tech Fee –Families will be charged a \$100 book/tech fee per K-8 student and a \$50 book/tech fee per PreK student at our 2021 Orientation Day. This fee is non-refundable.

## PAYMENT PLANS

**NOTE** – all payment plans are required to make a \$50 non-refundable deposit fee per family at the time of enrollment. The deposit will be applied toward tuition. All new students must pay a \$25 new student fee in addition to the \$50 deposit.

**OPTION 1:** Single Payment due **August 12, 2021**. Payment is made directly to the school.

**OPTION 2:** Two Payment Plan: Two equal payments are made directly to the school.  
1st payment due **August 12, 2021**      2nd payment due **January 12, 2022**

**Note:** A \$25.00 charge will be assessed monthly for late payment of Option 1, 2 and 4.

**OPTION 3:** FACTS monthly payment plan - payments are debited from your bank account over 10 months beginning July 2021 through April 2022. Payments may be made either on the **5<sup>th</sup>** or **20<sup>th</sup>** of the month. A one-time service fee of \$43.00 will be charged to each family by FACTS Management. **Note: A \$30.00 charge will be assessed by FACTS each time a payment is attempted and funds are not available.**

**OPTION 4:** Four Payment Plan: Four equal payments are made directly to the school.  
1<sup>st</sup> payment due **August 12, 2021**      2<sup>nd</sup> payment due **October 13, 2021**  
3<sup>rd</sup> payment due **January 12, 2022**      4<sup>th</sup> payment due **April 13, 2022**
