

PARENT/STUDENT AGREEMENT IN REGARD TO ONLINE/VIRTUAL LEARNING

I/we, the parent(s) or legal guardian (hereinafter referred to as “Parent”) of _____, and _____ (“Student”) make the following agreement with _____ (“Parish School of Religion” – formerly known as “CCD”) in regard to online/virtual learning provided by the Parish School of Religion:

- 1) “Parent” agrees that, in addition to and/or in lieu of in-person learning and education provided by Parish School of Religion or in partnership with a third party, that Student, may at times participate in online/virtual learning provided by Parish School of Religion.
- 2) At all times during any period of online/virtual learning, “Parent” and Student further agree to abide by any and all policies, rules and/or regulations of Parish School of Religion, including but not limited to those set forth in the Parish School of Religion’s handbook.
- 3) In addition, as a specific consideration of allowing Student to participate in online/virtual learning provided by Parish School of Religion and, further, in consideration of the privacy rights of Student and other students and any catechists or educators of Parish School of Religion, “Parent” and Student agree not to copy or record or send and/or re-transmit any online/virtual learning, in any form, to any other person or entity or file or place or post any online/virtual learning on any site on the internet or on any form of social media.
- 4) The only exception to Provision 3 above, occurs in those instances with the specific authorization of the catechist and/or parish school of religion leadership in furtherance of a lesson that is to be completed and returned to the catechist and/or parish school of religion leadership. In such instance, the recording may not be shared or sent and/or re-transmitted, in any form, to any person or entity or file or placed or posted on any site on the internet or on any form of social media other than that specifically designated by catechist and/or parish school of religion leadership for that lesson. Once the lesson is complete and receipt acknowledged by the catechist and/or parish school of religion leadership, any recording of the lesson involved must be permanently deleted from all electronic storage.
- 5) “Parent” and Student understand that failure to abide by this provision may result in Student being barred from any further online/virtual learning and/or any other discipline deemed appropriate, in the sole discretion of Parish School of Religion, including but not limited to expulsion from Parish School of Religion.
- 6) “Parent” and Student understand and agree that although Parish School of Religion is offering online/virtual education at this time, Parish School of Religion may terminate the option for online/virtual learning at any time and require personal attendance of Student at school for continued enrollment. Additionally, Parish School of Religion may in its sole discretion from time to time impose additional requirements not contained herein or otherwise modify this Agreement as a condition to Student’s continued participation in online/virtual learning.
- 7) The provisions of this Agreement shall supersede any provisions of the Parish School of Religion handbook or policies to the extent they may contradict.
