From Father Mike

Today's second reading from Paul's first letter to the Corinthians is a well-known passage since it is probably the most popular selection used at weddings. It contains a litany of the many aspects of love that speaks to the kind of marriage for which couples strive. Nevertheless, it can apply to any of our relationships with others, both one-on-one and in groups. Addressing the members of the church in Corinth, Paul was encouraging their greater unity as a Christian community since they were really struggling to get along with each. I would offer that we have some of the same challenges in our parish and wider church today. While we can be cordial and civil with each other at times, I believe we need to acknowledge there can be divisions among us. As I listen to how Catholics talk, in which activities people will or will not participate, or what gets posted on social media, I see we still experience disunity in our local and national church life. In some ways it can be a relief to know that the church has always struggled with maintaining unity, resolving controversy, and learning how to live more like the Body of Christ. Still, each generation of Catholics, including ours, must engage in the work of living a life of union with our fellow disciples that being a Christian demands. May the Eucharist we celebrate strengthen our communion with Jesus and one another.

INCLEMENT WEATHER

Remember that even if Mass is not cancelled, it is not a sin if your prudent judgment dictates that you should not put your health in danger because of extreme cold or conditions that increase your risk of injury.

VICTIM ASSISTANCE MINISTRY-REPORTING AN INCIDENT

Who Should Make Reports:

- Victims of child sexual abuse by a person ministering on behalf of the Church
- Persons with a suspicion that a child may be sexually abused by a person ministering on behalf of the Church
- Persons concerned about violations about our Code of Conduct regarding appropriate behavior with children by any person ministering on behalf of the Church

How to Make a Report:

Indiana law requires any person who has reason to believe that a child is a victim of abuse or neglect must report immediately to:

- The local Child Protection Services agency (Hotline: 800-800-5556); or
- A local law enforcement agency. Under Indiana law, it is a criminal act not to make such a report. This law applies to all adults without exception.
