All staff have been trained in proper cleaning protocol and maintain their own working space throughout the day. Sacred Heart Catholic School follows the guidelines put forth by the CDC.</p> <p>All staff, children, and parents/guardians are screened (temperature check and health check inquiries) upon entering the building. Screening is completed and documented by the principal and administrative assistant.</p> <ul style="list-style-type: none"> • Ask staff and adults if they or their children have had been exposed to a positive and presumptive case of COVID-19 <ul style="list-style-type: none"> ○ If yes, the exposed person must undergo quarantine for 14 days. The smallest classroom is approximately 900 square feet. Most furniture has been removed from each room to allow for 35 square feet per child. All desks and tables are spread out to allow for social distancing. Tape is utilized to mark boundaries on the floor and all rooms occupy no more than 18-20 children and 1 staff member at a time. Each room can accommodate between 23 and 26 children. Small cohorts that can be socially distanced in a greater space enables Sacred Heart Catholic School to avoid crowding and gathering.</p>

There are less than 68 children total in the facility in any given week.</p> <p>All contact tracing logs will be kept for a minimum of 4 weeks and provided to the Marion County LEA upon request.</p> <p>Interactions are minimized between cohorts by monitoring bathroom times, hallway traffic, and limitations to activities outside of work area. Tape aids in managing traffic.</p> <p>Sacred Heart Catholic School uses HOCl water to disinfect the facility at the end of everyday and periodically throughout the day if a particular area is not to be used. This includes bathrooms, hallway, rooms, and devices. HOCl water is also used in small spray bottles throughout the day by staff. Hand sanitizer is provided upon entry into the school and in every room. Lysol and/or alcohol wipes are used for the smaller jobs (i.e. handles, desks, utensils, etc.)</p> <p>Handwashing practices are promoted and practiced by all staff and children. Hand sanitizer is available in each room.</p>

Children, adults, and staff that come to the school are:</p> <ul style="list-style-type: none"> • Temperature checks upon entering the doors in the morning – staff, students, and parents <ul style="list-style-type: none"> ○ Temperature checks will be completed by the principal and administrative assistant.

<ul style="list-style-type: none"> Note that muscle pain, headache, sore throat, new loss of taste or smell, diarrhea, nausea, vomiting, nasal congestion, and runny nose are also symptoms often associated with COVID-19.
