

St. Rita Catholic School Extended Care Program: 2020 – 2021

Before School Care (BSC) & After School Care (ASC) Registration

All students in grades K - 7 utilizing the Extended Care Program must bring appropriate face coverings with them to the Extended Care Program. Students will be required to wear the masks when indoors and whenever they are not able to be socially distant from other students.

Students participating in extended care will remain with their static homeroom group.

BSC is provided beginning at 7:00am for all students except 2-year olds (TT2). The earliest TT2 can be dropped off is 7:30 am.

Students in grades PK4 - 7 attending BSC will enter through the doors on Ravan Avenue and report to the teacher on duty.

Students in TT3 attending BSC will enter the Imperial Woods gate and go directly to the TT3 building. Older siblings of TT3 students must be brought by the parent to the teacher on duty at the school's courtyard office doors.

The fee for BSC is \$3.00 per child per day. This does not include breakfast. All BSC students will enter their homeroom class at 7:30am.

School Food and Nutrition Services will begin serving breakfast at 7:30am. The cost for breakfast is \$2.00. Students purchasing breakfast will pick up breakfast in the cafeteria and return to their homeroom class to eat. Parents interested in the Free and Reduced Food Program should contact the cafeteria manager for information.

Guidelines will be provided for students in after school extracurricular activities utilizing ASC as they become needed.

Participation in the Extended Care Program is a service afforded St. Rita School families. SRS students are expected to behave in a manner exemplifying the St. Rita student profile. Inappropriate behavior while participating in these programs will be dealt with accordingly and may result in the student being suspended or permanently removed from the program.

Accounts for BSC & ASC services must be current for students to continue receiving the services offered through the program. Any invoice not paid by the due date will result in suspension of school services until the account is made current.

A registration fee of \$15.00 per child is required for students to participate in the Extended Care Program.

THE CHARGE FOR ANY STUDENT NOT PICKED UP BY 5:30 PM IS \$1.00 PER MINUTE St. Rita School recognizes the need for aftercare and is happy to provide this service to parents. In partnership with St. Rita, parents are expected to be punctual and to pick up students from aftercare by 5:30pm. The 3rd time a parent is late for ASC pick-up, the parent will be required to meet with school administration before the child can return to the aftercare program.		

The Extended Care Program is NOT provided on the following special schedule days & holidays: Pecan Fest Bingo Friday, the Friday of Pecan Fest, the last day of school before Halloween, Thanksgiving Break, Christmas Break, Mardi Gras Break, Easter Break, Open House (1/04/2021), the last day of school, and all early dismissal days. Parents are reminded to consult each month's revised school calendar for days of extended care services. Parents will also receive emails reminding them of days when ASC is cancelled.

On days when after care is not provided, the charge for any student not picked up within 15 minutes of dismissal time is \$1.00 per minute.
