1. Father Paul opened the meeting with a prayer.
2. COVID-19 Update
 - All churches are currently in phase 1 which means they can only have services at 20% of their capacity.
 - Pastors conducted a survey and all parishes are operating at less than 20% capacity.
 - Father Paul will be meeting with the bishop to determine our confirmation and first communion schedule. **Post Meeting:** The bishop has granted permission for all pastors to conduct their own confirmation ceremonies.
3. Student Ministry Team (SMT) Update
 - Jeremy has graduated and will become a FOCUS Minister
 - Next meeting of the team will be August 3, 2020
 - The team has been meeting virtually since March.
 - More at Mid-Week is still being conduct virtually with approximately 5-6 students.
 - The team is in the planning process for the 2020 – 2021 school year.
 - The team is still planning on having a baccalaureate dinner when possible.
 - Name has been changed to Kalamazoo Catholic
4. FOCUS Update: Focus will not be returning for the 2020 – 2021 school year because it was felt, after discussions with the bishop, St. Toms could not continue to fund the program and there are other programs available with smaller financial commitments. Father Paul is currently looking at other programs.

7. Religious education
