

2019 - 2020 CARES Rates & Fees

Annual CARES Registration fee: \$15.00 per family

Fee enables the use of both *Before* and *AfterCare* programs. 2019-20 CARES Pre-Enrollment form must be submitted prior to using either CARES service.

CARES Year-End Late fee: \$25.00

Assessed to CARES accounts not paid in full by the last day that your child attends either CARES program. This fee is additional to any previously assessed late fees.

2019-2020 BeforeCare Rates & Fees:

- ◆ \$6.00/day for 1 child, or \$8.00/day per family of 2 or more children.
- ◆ \$10.00 late fee if balance not paid within 2 business days from date-stamp on emailed statement. Statements are emailed weekly.

2019-2020 AfterCare Rates & Fees for Pre-Scheduled Students

These rates apply only to students pre-scheduled by Friday morning (or last day of the school week) prior to attending any day of the following week.

1 child	\$7/day	\$14/day	\$21/day
2+ children	\$14/day per family	\$21/day per family	\$28/day per family

Online prepayment is due prior to service. A \$10 late fee will be assessed on any balance not paid within 2 business days from the *Prepayment Due Date*. Students will not be permitted to return to CARES until payment and late fee are received in full.

AfterCare Policy for Drop-In Students

Drop-In Students are not pre-scheduled for AfterCare by the Friday morning (or last day of the week) prior to attending any day of the following week. A \$5.00 fee is added to the prevailing rate in the rate table above. This fee is charged only one time per calendar week.

Payment online is due on the date of service. A \$10 late fee will be assessed on any balance not paid within 2 business days of the date of service. Students will not be permitted to return to CARES until payment and late fee are received in full.

Late pick-up fee: \$10 late fee assessed at 5:30pm; additional \$15 assessed at 5:45pm.

C.A.R.E.S. Program - Quick Look

Holy Family Regional Catholic School's *C.A.R.E.S.* program provides children with a Catholic environment extending the philosophy and values of Holy Family RCS into before and after school hours. *CARES* is open to all students enrolled at Holy Family Regional School. The program offers a balance between adult-directed and child-initiated activities, active and quiet times, and time for homework. *CARES* services are fee-based and separate from school tuition payments.

CARES Before School 7:00 - 7:25am

CARES After School 2:25 - 5:25pm

- ◆ On days with delayed openings (inclement weather) — no Before School *CARES*.
- ◆ On early dismissal days such as scheduled 1/2 days — no After School *CARES*.

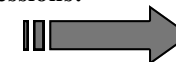

Beginning at 7:00am, *BeforeCare* provides a secure, adult-supervised environment prior to the (7:25am) official start time of your child's active school day. The *CARES* room offers a selection of toys, games, paper and crayons, etc. Students may also study; read; complete any work assignments they might have; or, maybe just relax before the school day

truly begins! *BeforeCare* is staffed by a Holy Family RCS classroom teacher.

Pre-Scheduling — At 7:25am, Holy Family RCS has one of the earliest opening times of any elementary school in our area. Consequently, only a small number of our students utilize the *BeforeCare* service on any given day. For this reason, **students must be pre-scheduled to use *BeforeCare* services.**

When no students are registered for a given day, the *BeforeCare* program is not be available or staffed for that day. So, it is important for parents and guardians to **pre-schedule** students and to notify *CARES* of changes to your child's *BeforeCare* schedule in a timely manner.

Students should have had a healthy breakfast prior to arrival at *BeforeCare*. Time constraints, do not allow for students to eat at *BeforeCare*.

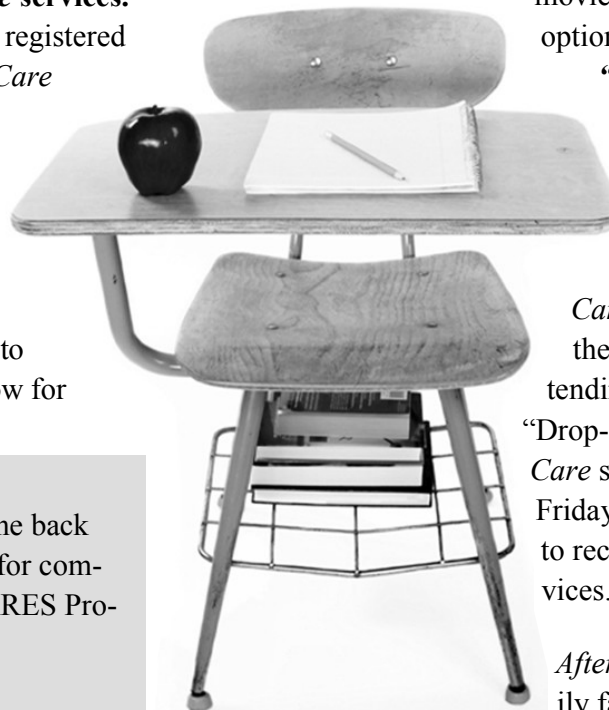

AfterCare staff supervise your child for a snack (provided by the school); homework (Grades 2 and higher); and some playtime after school until you are able to pick them up. Although it's not exactly home, we try to make it relaxed, fun and comfortable! There are a variety of activities for all ages:

- ◆ PlayStation2®; bins full of Legos®; cars and action figures.
- ◆ A castle, dollhouse, play-kitchen and more.
- ◆ Card games & board games.
- ◆ Crayons, markers, paper, glue sticks, and other craft options.
- ◆ Beginning in October, students (Grades 1 & older) go to the gym each Thursday for 1-1/2 hours of fun and exercise — a weekly favorite!

- ◆ "Friday Flicks" are offered every other Friday. A family-friendly movie is featured as an optional activity in our **"*AfterCare Surround-Sound Theater.*"**

Pre-scheduling and prepayment is required for *AfterCare*. Students not pre-scheduled by Friday mornings (or, the last scheduled day of the school week) prior to attending any day of the following week are considered "Drop-Ins" and pay an added weekly "Drop-In" fee for *AfterCare* services. Pre-scheduling and payment are due on the Friday morning before the week you are scheduling in order to receive the lower pre-schedule rate for *AfterCare* services. Our late pick-up policy is outlined on our website.

AfterCare is staffed by the *CARES* director and Holy Family faculty.
