Enrollment

For those enrolling students who are new to our school, please complete a new student enrollment application online using this link:

Once enrollment is submitted online, families with new students will need to finalize the enrollment process in the school office with additional paperwork needed (i.e. birth certificate, immunization records). Please note that Pre-Kindergarten students must be 3 years of age by February 1, 2021 and be able to use the toilet independently. Kindergarten students must be 5 years of age by August 1, 2021.

Enrollment Fee

There is a non-refundable enrollment fee of \$150 per child or \$200 per family, which will be billed to FACTS Payment Plan upon registration and will secure your child's placement at St. Anthony de Padua Catholic School. Payment Plan accounts must be set up and activated prior to enrollment application processing. Enrollments without FACTS setup will be placed on hold. The registration fee will only be refunded if admission is denied by St. Anthony School.

Active Parishioner Information:

- 1. All three (3) of the following requirements must be met to receive a Parishioner Tuition Subsidy towards the cost of student education at St. Anthony de Padua Catholic School (please check all that apply):
- 2. Parish Registration Family members are baptized, and the family has been registered at St. Anthony de Padua for the past year. (Please contact church@stasb.org to register or inquire about registration status). Note: If transferring registration from another parish, please provide a letter from the parish office of the previous parish confirming your "active parishioner" status.
- 3. Mass Attendance with Offering Envelope/eGiving Usage The family regularly attends Mass at St. Anthony de Padua Catholic Church on Sundays and Holy Days of Obligation. (Some Sundays, of course, you may be attending other places because of vacation or otherwise being out of town). Financial support of the parish is also an important part of being an active parishioner. Using offering envelopes or eGiving allows the pastor to know of your support. The Parish community realizes families may experience hardship in making monetary offerings on a regular basis. For those that are unable, your intention to give is made evident by the simple placement of the offering envelope in the collection basket each week, even if the offering envelope is empty or contains only a small amount.
- **4.** Stewardship: Time/Talent/Treasure Families proactively contribute their time, talent, or other treasure to the Parish and School community through participation in the liturgy (Eucharistic Ministers, Lectors, ushers, greeters, etc.) and/or at Parish and School ministries, committees, programs, events, etc. https://stasb.org/ministrysignup

Annual Review of Active Parishioner Status

The Diocese has asked all parishes to obtain an "Affidavit of Active Parishioner Status" each year at the time of School Registration (January/February). Each family seeking a Parishioner Tuition Subsidy will be asked to complete an Affidavit of Active Parishioner Status at the time of registration for the Pastor's review of compliance with the above criteria. Tuition subsidy will be granted or denied for the upcoming school year based on this annual review. Those registered at other parishes will have a request sent to your pastor to review and sign.

Payment Information:

- Monthly Payments are managed through FACTS Payment Plan.
- Enrollment (class placement) is not final until:
 - Tuition and any other fees due to the school for any previous school year are paid in full, and
 - FACTS Payment Plan setup has been completed (Payment Plan setup may be completed online <u>all families</u> for billing purposes, including those making a one-time payment and those receiving a School Choice youcher.
- Upon withdrawal or transfer to another school during the school year, all fees included in tuition will be due and payable in full at that time, unless sufficient payment has been made to cover these fee amounts. Tuition will be prorated based upon 180 days of school from the first day of attendance to the last day of attendance.
- Payment of any balance owed to St. Anthony is required for future acceptance into another Diocesan school, including high school, and for the transfer of student records to any public or private school.

Tuition Assistance

We are happy to offer several types of Tuition Assistance at St. Anthony for grades Kindergarten through 8. A FACTS Grant & Aid application is required for eligibility determination at https://online.factsmgt.com/signin/3FFKJ. Parishioners are encouraged to apply for a Pastoral Scholarship, regardless of income.
