I the undersigned user, agree to release and on behalf of myself, my heirs, representatives, executors, administrators, and assigns, HEREBY DO RELEASE Camp Hammer, its officers, agents, and employees from any cause of action, claim, or demand of any nature whatsoever, including but not limited to, a claim of NEGLIGENCE, which I, my heirs, representatives, executors, administrators and assigns may now have, or have in the future against the Camp Hammer on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to my use of the Climbing Tower or Challenge Course whether that use is supervised or unsupervised, however the injury or damage is caused, including, but not limited to the NEGLIGENCE of the Camp Hammer, its officers, agents, and employees. In consideration of my use of the Climbing Tower and Challenge Course, I, the undersigned user, agree to INDEMNIFY AND HOLD HARMLESS Camp Hammer, its officers, agents, and employees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to my use of the Climbing Tower and Challenge Course. I hereby certify that I have full knowledge of the nature and extent of the risks inherent in the use of the Climbing Tower and Challenge Course and that I am voluntarily assuming the risks. I understand that I will be solely responsible for any loss or damage, including death, I sustain while using the Climbing Tower and Challenge Course and that by this agreement the Camp Hammer of any and all liability for such loss, damage, or death. I further certify that I am in good health and that I have no physical limitations which would preclude my safe use of the Climbing Tower and Challenge Course. I also acknowledge that my participation is voluntary and I will only participate to the extent I feel appropriate for my skill level. The activities on the tower and ropes course are strenuous and psychologically demanding and require participants to be in good physical condition. Although it is impossible to foresee all possible dangers, some specific risks the participant may encounter while using the tower or ropes course might include, but are not limited to, injury from slipping, falling, running, or jumping. Finally I state that I am not under the influence of any chemical substance of alcohol.
