### STATUS OF DOCUMENTS

- 1) Whenever a marriage is to be performed *outside the Diocese of Stockton*, this form, properly filled out, together with all other required documents (Form A, B, baptismal record, dispensations/permissions, etc.), is to be submitted in good time to the Chancery Office. After the "nihil obstat" has been placed thereon by a duly authorized Chancery official, this document and all the other documents are to be forwarded to the parish where the marriage is to take place. All of the documents are to be filed in the latter parish.
- 2) When a marriage is to be performed outside the proper parish, *but within the Diocese of Stockton*, this form, properly filled out, is to be sent to the parish where the marriage is to be performed. All other documents are to be kept in the files of the proper parish. (The "nihil obstat" of the Chancery is not required in this circumstance.)
