## Eligibility Requirements

---

1. An applicant must have achieved an overall High School GPA of 3.0, or a combined GPA of 3.0 for their Junior and Senior year. In the case of a renewal scholarship, a minimum of a 3.0 GPA in the previous college year is required.
2. An applicant must be an active, practicing Catholic.
3. An applicant must exhibit leadership traits through active participation in school activities and/or involvement in community activities.
4. An applicant eligible for the scholarship will have graduated from and have attended a minimum of grades 5 through 8 at Bishop Baraga Catholic School.
5. An applicant will be a graduate of one of the following High Schools: Kingsford, Iron Mountain, Niagara, or Florence. Worthy graduates of other area High Schools could be considered on a case by case basis.
6. An applicant must demonstrate economic need to the satisfaction of the Selection Committee. Economic need will factor into the decision of the selection committee, however, all worthy applicants will be considered.
