

## **REQUIREMENTS:**

- ➤ The *student* must be the child or grandchild of a member of CDA Court #2292 or of a registered parishioner of St. Luke the Evangelist Catholic Church.
- ➤ The student must submit a certified copy of his/her transcript of high school grades. The transcript should remain in the sealed envelope and must be submitted it with the application.
- > Two letters of recommendation must be submitted along with the application. Letters should reflect your case for scholarship need and future potential. One of the letters must be from a registered member of St. Luke Parish or from a member of the church you attend. The other letter may be from any source familiar with the student and his/her character. Letters from immediate family members will not be accepted.
- > The student must submit a one page handwritten letter stating why you believe you deserve the scholarship
- > The *student* must meet all qualifications for entry into college/university and must be accepted by an accredited college/university.
- > The student must have maintained a minimum of a "B" average in high school.
- > The *scholarship money* will be paid directly to the college or university of the scholarship winner's choice.
- ➤ The winner(s) is to be selected by the CDA Scholarship Committee based on his/her application and all required documents. The winner(s) will be announced at the St. Luke Graduation Mass on May 22, 2021.
- ➤ The application and all required documents must be received by May 3, 2021.
