PASTOR'S CORNER

In today's scriptures, the angel announced that Mary was God's chosen one for a temporary dwelling place on earth. The angel told Mary that the reign of King David would likewise run right through her body in the conception of a child whose kingdom would have no end. Mary let God be God. She remained open - open to surprise -- and here she is called "blessed" among women, unlike David (in our old testament reading) who tried to control.

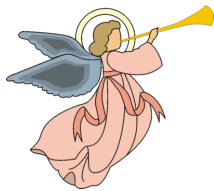
