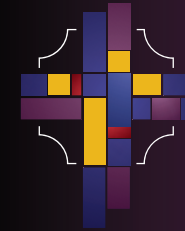
Here are some instruments to consider:

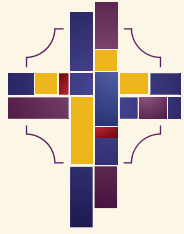
