When couples keep a strong divine intimacy their human intimacy finds new depth, vigor and joyfulness. When divine intimacy is missing, they will run out of wine and steam. Keeping the Lord as the lover of their souls and center of their family life, couples can become great stewards of Marriage. Let us pray for all the couples in our parish and pray for those who are aspiring to stay in loving commitment.

I am glad to see that we are many great families who are wonderful stewards faithful to their sacrament of marriage and family life. It is said that there is no more lovely, friendly and charming relationship, communion or company than a good marriage. May God bless all Marriages to be faithful and fruitful.
