CATECHISTS

A catechist is a practicing Catholic who volunteers to be a sponsor for a person with a developmental disability. A catechist must be an adult 18 years of age or older.

CONSENT FORMS

All Forms must be filled out at the beginning of every SPRED year prior to joining the SPRED Center. A copy must be filed with your SPRED center and with the diocesan administrative office. This ensures that that the office has a proper enrollment of who is participating in the ministry and in the parishes. These forms include but may not be limited to; the Participant Form, Catechists form, Video & Photos Release form, and other forms that may be requested by your parish.

ELIGIBILITY OF CATECHISTS

A volunteer, 18 years or older, has agreed to complete Safe Environment (fingerprints and Safe Environment training) before joining the group. Additionally, it is necessary to take the SPRED trainings before the SPRED year begins or within one year of joining SPRED. The volunteer catechist agrees to attend 12 catechist preparation sessions and 12 integrated sessions (total community) from October to May (approximately 2-3 hours per session) and SPRED Liturgies, both the Diocesan and within the parish. The volunteer also agrees to abide by the SPRED standards, contract and policies in SPRED.
