Limited space available.

FEE: \$100.00 per booth. Additional \$5.00 if you would like electricity. Availability is limited.

PAYMENT: Please make check or money order payable to *St. Elizabeth Ann Seton Women's Group* and submit with your application prior to the jury date. We will honor specific booth requests based availability and the date we receive your application with payment.

JURY DATE: **JUNE 1, 2022.** All crafters *new to the show* must submit at least 3 images representative of your craft work in progress, or finished work and booth display. RESTRICTIONS: All craft items **must be handmade**, at least in part. You may incorporate purchased, recycled, or repurposed items in your craft, but the items you sell *must have some element of your own original handiwork*.
