Dear St. Veronica Parents,

Welcome to the 2021-2022 school year! This letter is intended to answer many of the frequently asked financial questions by families each year. If you have any questions regarding tuition, please contact the Business Office at 513-688-3142.

The window to apply for financial assistance is now open. When you apply for financial assistance in FACTs, your application is submitted to St. Veronica **and** the Archdiocese for One Faith, One Hope, One Love scholarships, as long as you check you want to be considered for both. To be considered for the Archdiocesan scholarship, you must apply by February 8, 2021. This scholarship can be up to \$1,200 per student, and letters will be sent directly from the Archdiocese. No additional paperwork is required for the Archdiocese scholarships.

To be considered for the St. Veronica scholarship, you must apply by May 7, 2021. St. Veronica and the Archdiocese of Cincinnati utilize FACTs, a third party organization, who analyzes family financial information to assist in tuition financial assistance decisions. FACTs charges a \$43 fee for enrolling in their system.

After this initial analysis, St. Veronica will make financial aid decisions mid-May and will send letters to all families who applied for financial aid at St. Veronica. Please keep in mind that families must meet the “active parishioner” guidelines, i.e., Mass attendance as determined by the number of envelopes or Faith Direct cards (not by the contribution amount) and volunteer in at least one parish ministry or organization activity each year. Both criteria must be met to be considered for financial assistance.

After the FACTs online application has been completed, the following information will need to be uploaded to FACTS to complete the application process:

- Copies of your most recent Federal tax forms including all supporting tax schedules.
- Copies of your 2020 W-2 forms for both you and your spouse.
- Copies of supporting documentation for Social Security Income, Welfare, Child Support, Food Stamps, Workers’ Compensation, and TANF.

All supporting documentation can be uploaded in PDF format online. Documentation can also be faxed to 866-315-9264 or mailed to the address below. Please be sure to include the applicant ID on all faxed or mailed correspondence.

If you have questions or concerns about the FACTs application process, you may speak with a FACTS Customer Care Representative at 866-441-4637.

Starting in 2020, St. Veronica became an EdChoice and EdChoice Expansion Provider. If you are in a public school district that is eligible for the Ed Choice Scholarship or meet the financial guidelines for the EdChoice Expansion Scholarship you can apply through the school. You can find the list of school districts, the financial guidelines, and the application on their website at [education.ohio.gov](http://education.ohio.gov).

Additional St. Veronica information:

- The St. Veronica registration fee is due at the time the complete registration forms are returned to the school office. All additional fees can be included in future payments.
- If you are not paying in full, you must be enrolled in the FACTs system **by May 28, 2021 and are not considered registered until this step is complete**. A \$43 fee is assessed by FACTs for using their system, and a 2.85% fee is charged by FACTS for using a credit card instead of EFT. A 5% finance fee is charged by St. Veronica for monthly payments on financed tuition. **Registration is not considered complete until payer is enrolled in FACTS by May 28, 2021.**
- To receive the “Active Parishioner” tuition rate, the family must attend Saturday or Sunday Mass at least 27 times per year and volunteer for one organization, ministry, or parish-sponsored event or fundraiser. An audit is managed each year in December to check Mass attendance. If you have not met the requirement for Active Parishioner, the difference in tuition will be added to your FACTs account or invoiced for payment. You will have to register as Non-Active the following school year.
- **Tuition Policy regarding delinquent payments:**
  - There will be a \$30.00 fee for late payments that are received after the 15th or last day of the month, whichever is selected by the family.
  - There will be a \$30.00 fee for insufficient funds.
  - If tuition is not current and no arrangement with the Business Manager has been made prior to registration or the opening of school the child will not be accepted into school for that year until the delinquent tuition is resolved.
  - If tuition is delinquent for **two** months, students will not be permitted to return to school until the delinquent tuition is resolved.
  - No 8th grade student may take final exams until **all** financial obligations are current.
  - No school records will be forwarded until all financial obligations are current.
  - Accounts with a history of continuous delinquency will **not** be offered the finance payment plan option the following school year.

The tuition rates for the 2021-2022 school year are:

**Preschool**

- 3 year old 2 day ½ Day \$175.00/month (\$1,750.00 annual)
  - 3 year old 3 day ½ Day \$220.00/month (\$2,200.00 annual)
  - 4 year old 3 day ½ Day \$220.00/month (\$2,200.00 annual)
  - 4 year old 3 day Full Day \$360.00/month (\$3,600.00 annual)
  - 4 year old 5 day ½ Day \$280.00/month (\$2,800.00 annual)
  - 4 year old 5 day Full Day \$505.00/month (\$5,050.00 annual)
- (A Non Refundable Registration Fee of \$75.00 per family is required for preschool registration)

# St. Veronica Parish School Registration Procedures 2021-2022 School Year

Registration will be accepted during the following time periods:

## #1 **Beginning January 11, 2021**

- For all St. Veronica School students currently enrolled who are in grades Pre-school through 7. This period includes both “Active Parish” and “Non-Active / Out-of-Parish” students currently enrolled and attending St. Veronica School.
- Registrations for siblings of currently enrolled “Active Parish” students will be accepted at this time; siblings will be given priority in grades Pre-school through 7. If the number of sibling registrations should cause enrollment to exceed capacity at any given grade level, admissions will be accepted on a first come-first served basis from registrations received in that registration period.

## #2 **Beginning January 18, 2021**

- For any parish member who wants to transfer a student from another elementary school to St. Veronica School in grades K-8. If the number of parish registrations should cause enrollment to exceed capacity at any given grade level, admission will be accepted on a first come-first served basis from registrations received in that registration period. Registration for Pre-school will be accepted at this time for parish members.

## #3 **Beginning January 31, 2021 - OPEN REGISTRATION**

- For any “out-of-parish” family who wants to transfer a student from some other elementary school to St. Veronica School in grades K-8 and Pre-School.
- If the number of registrations should cause enrollment to exceed capacity at any given grade level, admissions will be accepted on a first come-first serve basis among siblings of currently enrolled “out-of-parish” students and then of new “out-of-parish” students.

**It is imperative that families register during the assigned time periods in order to have optimum chance of securing admission to St. Veronica Parish School for the 2021-2022 school year.**

- Technology Fee of \$125.00 per student K-8 (\$60.00 Half Day Kindergarten)
- Copy of Birth Certificate for each child **(pre-school/kindergarten/new students)**
- Copy of Catholic Baptismal Certificate for each child **(kindergarten/new students)**  
*(If child was baptized at St. Veronica Church, a copy of the certificate can be obtained at the parish office and must be included with registration)*
- Record of Immunization signed by the physician **(preschool/kindergarten/new students)**
- Copy of recent report card and standardized test results **(transfer students only)**  
*(We will not accept registration without test results)*

#### IMPORTANT INFORMATION:

- **The registration fee is due at the time the completed registration forms are returned to the school office.** All additional fees (Student Fee and Technology Fee) may be included in future payments.
- **You must be enrolled in the FACTS system (factsmgt.com) if you are not paying in full.** A \$43 enrollment fee is assessed by FACTS for using their system, and a 2.85% fee is charged by FACTS for using a credit card instead of EFT. A 5% finance fee is charged by St. Veronica for monthly payments on financed tuition. Any questions regarding tuition payments or FACTS, please contact our business office 513-688-3142.

**Tuition Options**

- Payment in Full (Early registration – **January 11 - February 12, 2021**)
- Payment in Full (**February 15 - May 28, 2021**) Payments are subject to **0.5%** fee per month for any partial or full month **after May 28, 2021**.
- Partial Payment (Due **May 28, 2021** – balance processed monthly same as monthly payment option)
- Monthly Payment (**July - April**) processed through **FACTS** Tuition Management and payable by EFT or Credit Card.

**A \$43 fee is assessed by FACTs for using their system, and a 2.85% fee is charged by FACTs for using a credit card instead of EFT.**

**A 5% finance fee is charged by St. Veronica for monthly payments on financed tuition. Registration is not considered complete until payer is enrolled in FACTs by May 28, 2021.**

Checks payable to St. Veronica School. A 5 day grace period will be provided for late payments. If the payment is not made within the grace period, a \$30 late fee will be assessed.
