ST. THERESE SCHOOL K-8 2021-2022 ACADEMIC YEAR

This agreement outlines your family's direct fundraising and volunteer service requirements for the period of July 1, 2021 through June 30, 2022.

St. Therese School is funded by tuition, parish subsidy, donations and Home & School Association fundraising activities. Since tuition covers only part of the total cost of the education of your child/children, parents and guardians are requested to involve themselves in activities to assist the school. These activities include fundraising and volunteer service activities. Participation in fundraising events and volunteer service fosters a sense of community and mutual responsibility for the school and our children while ensuring the financial viability and future of St. Therese School.

The following shall be completed with Tuition Contract.

PART I: HSA DECEMBER 50/50 RAFFLE OBLIGATION:

The Family/Signee will receive three (3) \$100.00 tickets [50/50 Raffle] to own or sell and three (3) chances to win a free year's worth of tuition [Tuition Raffle] for one child at the current Active Parishioner Tuition rate.

- Payments can be made in three equal payments of \$100.00 due as follows:
September 15, October 15, November 15, 2021, or paid-in-full at any time prior to September 15, 2021.
Checks should be made payable to "St. Therese School HSA 50/50 Raffle".
- For each additional \$100.00 ticket sold by the Family/Signee before the drawing, the Family/Signee will receive one additional [Tuition Raffle] entry.
- If the winner of the Tuition Raffle is the Family/Signee of an eighth-grade student, who is the only child attending St. Therese School, they will receive a check for the value of tuition for one child at the current Active Parishioner Tuition rate.
- The Family/Signee agrees to being invoiced for unsold/unremitted tickets and that the SANCTIONS LISTED will apply until reconciled.

PART II: HSA CALENDAR RAFFLE SALE OBLIGATION:

The Family/Signee will receive ten (10) \$10.00 tickets [Calendar Raffle] to own or sell. All remittance is due by January 28, 2022. The Family/Signee agrees to being invoiced for unsold/unremitted tickets and that the SANCTIONS LISTED will apply until reconciled.

PART III: HSA SCRIP FUNDRAISING PROGRAM OBLIGATION:

The SCRIP Fundraising program is an unlimited cash-back program, and each Family/Signee is required to participate in the SCRIP Fundraising Program. There are two ways to fulfill this obligation.

Please select ONE by marking / circling your selection. If a selection is NOT MADE, it will default to item #1.

1. Family/Signee will remit the \$250.00 Scrip Fundraising Program Fee up front via check made payable to "St. Therese School SCRIP", due September 15, 2021. If this remittance is NOT received by September 15, 2021, the Family/Signee agrees to being invoiced and that the SANCTIONS LISTED will apply until reconciled OR
2. Family/Signee agrees to utilize the Scrip Fundraising Program through May 31, 2022, earning \$250.00 in Rebates for St. Therese School. The Family/Signee agrees to be invoiced for the SCRIP Fundraising Program Fee of \$250.00, less any rebates earned for the SCRIP Fundraising Program usage period from June 1, 2021 through May 31, 2022. This Fee balance will be due by June 30, 2022.

Any Rebates earned by the Family/Signee that exceed the required \$250.00 Program Fee will be refunded to the Family/Signee on or about July 15, 2022.

PART IV: HSA TRICKY TRAY EVENT OBLIGATION:

The Family/Signee will donate either a prize, gift card(s) OR check worth \$75.00 or greater in value to the St. Therese School Tricky Tray fundraiser. All donations/remittance are due no later than October 15th, 2021. The Family/Signee agrees to being invoiced \$75.00 for an unfulfilled Tricky Tray obligation and that the SANCTIONS LISTED will apply until reconciled.

PART V: HSA BINGO EVENT OBLIGATION:

There are two ways to fulfill this obligation.

1. Family/Signee will work the Sunday or Monday Bingo estimated once every six weeks or find a substitute worker for their assigned date. The Bingo Team Schedule begins July 1, 2021 for St. Therese School contracted 2021-2022 families. The HSA Bingo Lead will issue a schedule to each family indicating the team/schedule for the upcoming school year by June 1, 2021.
2. Family/Signee elects to buy out of the Bingo Event Obligation by remitting \$800.00 via check made payable to "St. Therese School Bingo", due June 1, 2021.
