**\*\*LENTEN REGULATIONS...** The time of Lent is to be observed by Catholics as a special season of prayer, penance, and works of charity. Ash Wednesday (March 6<sup>th</sup>) & Good Friday (April 19<sup>th</sup>), in particular, are the most important penitential days of the liturgical year. They are days of both fast & abstinence. All Fridays in Lent are days of abstinence.

The rule of fasting states that only one full meal a day can be taken. Two small meals, "sufficient to maintain strength", are allowed, but together they should not equal another full meal. Eating between meals breaks the fast, but drinking liquids does not. The rule of fasting obliges all Catholics from 18-59.

Abstinence refers to the eating of meat. The rule of abstinence binds all Catholics 14 years & older.

The substantial observance of the laws of fast & abstinence is a serious obligation. Those whose work or health would be impaired are excused from fasting & abstaining. The individual conscience can decide if there is a proper cause to excuse. A more serious reason should be present to excuse from Ash Wednesday and Good Friday penance.

Self-imposed fasting on other weekdays of Lent is recommended. Abstinence on all Fridays of the year is also highly recommended.

Parents & teachers should see to it that even those who are not bound by the laws of fast & abstinence because of age are brought up in an atmosphere that is conducive to a sense of penance.

**regarding HR 57.**

This law goes too far.

My brothers and sisters, I write today concerning HR 57, a proposed state law that is currently working its way through the Vermont state legislature. You may have heard me say, "I am a pastor, not a politician," so I am speaking to you as your pastor. You know that our faith teaches that all human life is sacred – meaning "of God" - from the moment of conception to the moment of natural death and that we are called to embrace and protect that sacred gift that is the very breath of each of our lives. You are also aware that the teaching and ministry of the Catholic Church "since the first century has affirmed the moral evil of every procured abortion. This teaching has not changed and remains unchangeable. Direct abortion, that is to say, abortion willed either as an end or a means, is gravely contrary to the moral law." (Catechism of the Catholic Church 2271) As your bishop, pastor, and brother I am fully aware of the division that exists within our society and even within the family of our Church around these matters. I know that when I stand before you as your brother and speak to you concerning the issue of abortion that there are many, even within our Church, who sadly hold contrary opinions based on a woman's right to choose and the promotion of "reproductive freedom." But, even if you hold such opinions and allow for a so-called "right to an abortion," this proposed law goes too far.

HR 57 goes far beyond Roe vs. Wade, guaranteeing unrestricted abortion through all nine months of pregnancy and declaring the baby to have no individual rights. This means that a baby in the womb can be terminated right up to the moment of natural birth. My friends, that is not abortion. That is infanticide. And this law would legislate that right to an abortion – to that infanticide - not be "denied, restricted, or infringed by any government entity."

I plead with you, my friends. Do not let this happen. This law goes too far.
