St. Augustine of Canterbury School Registration Immunization Requirements and Forms

Dear Parents:

Immunization requirements for school attendance are regulated by the State of New Jersey and the South Brunswick Department of Health.

Pre-K 3 and Pre-K 4 students must provide proof of age appropriate vaccination for the following:

1. DT or Dtap
2. Polio
3. Measles, Mumps, and Rubella or MMR vaccination
4. Haemophilus influenza b (Hib). Booster given at 12 months or older.
5. Chicken Pox (Varicella) vaccination or proof of disease
6. PCV-7 or Prevnar
7. Flu Vaccine

Students entering Kindergarten or transferring into Grades K-5 must provide proof of age appropriate vaccination for the following:

1. DT or DTap: Booster must have been given at age 4 or after for school admittance
2. Polio: Booster must have been given at age 4 or after for school admittance
3. Measles, Mumps, and Rubella or MMR—2 doses or proof of immunity
4. Chicken Pox (Varicella) vaccination or proof of disease
5. Hepatitis B: 3 doses;

Students entering Grade 6 must have all of the above as well as the following vaccinations:

1. Meningococcal Vaccine: Menomune or Menactra depending on vaccine used
2. Tdap Vaccine: Boostrix or Adacel depending on age and vaccine used

Physical Exams are required for all students entering Pre-K, Kindergarten, Grade 3 and Grade 6, as well as all transfer students into other grades. Forms are enclosed with registration packet and may also be accessed online under Forms. **All Students Participating in team Sports or Cheerleading Must Have a Yearly Physical Exam on File or Participation Will Not Be Allowed.**

Medication forms are required to be on file for medication dispensed throughout the school day including prescription or over the counter medication. Your physician may give permission for administration of Tylenol for occasional headaches without fever directly on the Physical Exam Form.

If your child has food allergies or asthma, please call the health office for additional information and medical forms that do need to be filled out. Some state mandated asthma forms, food allergy and Epinephrine forms are also available online on the school website under Forms. If your child has other medical conditions that require medication or evaluation, please notify the health office for consultation.

Physical Exams, Immunization Forms, Emergency Forms, Medication Forms and Permission to Administer First Aid Forms must be returned as soon as possible, but no later than the first day of class in September. Please include any health information such as seasonal allergies, asthma, food allergies, or other medical conditions as well as any medication your child may be taking on a regular basis on the Emergency Form. Please do not hesitate to call if you have questions at any time throughout the school day or e-mail me at school. Thank you so very much for your attention to this important registration information.
