

# COVID-19 Public Testing Sites for Sangamon County area residents

- **Contact your health insurance provider to learn about what they cover before making an appointment.**
- **Insurance information will be requested; out of network service provisions may apply.**
- **You can get a COVID-19 test for no cost at an IDPH testing location.**
- **COVID-19 testing and treatment is covered by Medicaid.**
- **COVID-19 testing is covered for uninsured Illinois residents regardless of citizenship and immigration status through the Illinois Department of Public Health (IDPH).**

**Walgreens** (3 years and older) NO CHARGE TO PATIENT, SYMPTOMS NOT REQUIRED; Perform the nasal swab yourself under the direction of a pharmacy team member. Patients ages 3-18 will need a parent or legal guardian while they self-administer the COVID-19 test. For dates and times available and to schedule an appointment go to:

**CVS** (3 years and older) IF EXPOSED OR HAVE SYMPTOMS THEN NO COST TO PATIENT; TRAVEL AND ASYMPTOMATIC COST \$139; Patient or patient's assistant performs nasal swab. For dates and times available and to schedule an appointment go to:

**LLCC** COVID-19 saliva based testing. FREE TESTS to the public in partnership with SHIELD Illinois. Results are sent directly to each patient (or their guardian's) online SHIELD portal within 6-24 hours of testing. If symptomatic do not go inside the building, call 217-786-2077 and they will test you in your car. No eating, drinking (including water), smoking, chewing gum or brushing teeth 60 minutes before test. For dates and times available and to schedule an appointment go to

**UIS** COVID-19 saliva based testing site is now offering FREE TESTS to the public (non-symptomatic individuals who are not isolating due to COVID-19) in partnership with SHIELD Illinois, Results are sent directly to each patient's (or their guardian's) online SHIELD portal within 12-18 hours of testing. ## **Memorial Health Systems & Memorial ExpressCare**

Persons of all ages with symptoms may be tested and evaluated at ExpressCare locations, ExpressCare telehealth, Memorial Physician Services primary care (in person and telehealth), and Memorial Drive thru testing locations, with a physician order. Persons without symptoms that need testing for travel may walk in for testing at any ExpressCare location or obtain testing at a drive-thru location with a physician order. Charge is \$100. A COVID-19 PCR result will be emailed within 24 hours. For times and dates available and to schedule an appointment go to:

## **HSHS Medical Group Drive Thru**

Persons of all ages with symptoms, been exposed to COVID-19, or need a return-to-work or school test; testing under these conditions is covered by the federal CARES Act (no cost to patient.) For dates and times available and to schedule an appointment go to:

**Hy-Vee Stay-In-Car Testing (PRIVATE PAY ONLY)**

Persons 6 years and older can receive an antigen test at Hy-Vee, 2115 S. MacArthur Blvd, Springfield; the cost of \$129 must be paid by credit or debit card (billing insurance is not available.) Testing is available to patients who are symptomatic or who are asymptomatic with a known or reported exposure in the last 14 days. Test results are available in as little as 1-2 hours. **COVID Clinic – located at White Oaks mall near Dick’s Sporting Goods (behind Panda Express)**

COVID-19 PCR test is available with results in 1-2 days. Rapid testing for travel and other purposes is available at patient expense. All services may be submitted to health insurance; insurance network coverage policies will apply. Testing and physician orders for uninsured patients covered by the federal CARES act.
