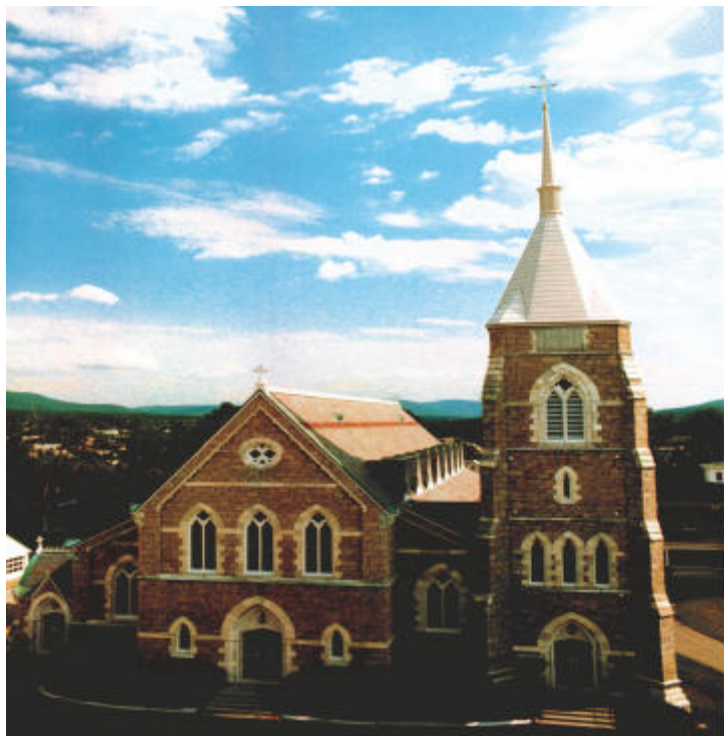

A reading on Conflict Resolution

according to the Gospel of Saint Matthew

Because we live in an imperfect world filled with imperfect people our lives are going to inevitably have some conflict in them. Conflict is simply part of living on this planet. As much as we try to we cannot avoid conflict. We may deny the presence of conflict. We may run from conflict. Yet conflict exists simply because human beings are human beings. We may wish conflict was absent from life however life without conflict is not life. Conflict has always been present in the human condition.

Conflict, like so many other unhappy parts of life, must be dealt with, for if we don't deal with conflict it will deal with us psychologically, emotionally and even physically. Conflict, which is ever present, was part of the experience of the followers of Jesus and so Our Lord gives his disciples a simple spiritual way to deal with conflict, to resolve it as it were. The Lord also indicates what is to be done when conflict cannot be resolved. For sadly, not all conflict is resolvable.

Since for us Roman Catholic Christians the Gospel is the ultimate truth the Gospel teaching about conflict is most pertinent for us today. There are three steps that Jesus recommends to be followed in order to deal with conflict. The first, second and third steps are steps involving communication. For communication is the key to resolving conflict.

Communication of feelings, of facts, of impressions, or expressions and of interpretations is the best way to reach understanding. Without clear and face to face communication genuine understanding is impossible to achieve. Understanding is the foundation of conflict resolution. The Gospel indicates that communication first takes place between individuals, one on one. However, if this fails, communication must continue but with the help of an arbitrator or two, who would be a neutral party. Should this fail the communication can continue within a group setting or as the Gospel states "The Church". In fact, groups can enhance communication by offering different options, possibilities and directions to conflicting parties which might not surface with only one or two arbitrators. Lastly, should this fail to bring about a resolution detachment is the only answer. However, detachment based on acceptance of differences must be done with charity and love since our Lord never stopped loving those who were "Gentiles or tax collectors" despite the different worlds they lived in. It seems Our Lord loved them all the more.

Not all conflict can be resolved. Nevertheless, as disciples of Jesus Christ we must never stop trying to resolve it. Honest and open communication accompanied by a loving respect can heal many divisions. The Gospel assures us that although we cannot resolve every conflict we can live with conflict peacefully.
